Dear Executive Director:

The purpose of this letter is to notify you that on September 11, 2024, the Department of Community Services and Development (CSD) received an additional funding award of Community Services Block Grant (CSBG) funds for Fiscal Year (FY) 2024 from the U.S. Department of Health and Human Services (HHS). The funding award under this release is \$411,785.00, increasing California's 2024 CSBG award to \$68,790,790.00.

The additional funding release represents funds that were offset from the current year's appropriation as a result of administrative action taken by the Administration for Children and Families under Public Law 118-47, the Further Consolidated Appropriations Act, 2024.

Attached is the third 2024 CSBG contract amendment for the term of January 1, 2024, through April 30, 2025. The effective date of this amendment is November 15, 2024.
