AOD Updates

As of the preparation of this report, there was no direct negative impact to AODS programs resulting from the May Budget Revise. The SAMHWORKS budget will remain at same level as FY23-24. BH however, continues to proactively monitor the impact of the implementation of Proposition 1 also known as the Modernization of the Mental Health Services Act (MHSA), including the integration of the Mental Health Commission and the AOD Board into the emerging Behavioral Health Advisory Board. In addition, in AODS we continue to be actively involved in other CalAIM initiatives such as CARE Court, SB43 (Eggman), Justice Involved and overall administrative integration of BH Administration. Lastly, we are closely collaborating with Diablo Valley College (DVC) to increase understanding of substance use amongst mental health staff.

Electronic Health Records (EHR) SmartCare

Following the first-year anniversary of SmartCare implementation, staff remains involved with CalMHSA to ensure that Contra Costa prioritizes upgrades to the system based on provider needs and State requirements. Communication with providers regarding changes are immediately conveyed via virtual Brown Bags and Tip Sheets. Our organizational goals for EHR remain: 1) System optimization, 2) Interoperability between SmartCare and EPIC and 3) Client access to their own records/charts in SmartCare, in the same way they see their medical information in EPIC.

Standing Report Items

Crossroads Program - Treatment in the Jail

Services in the Jails continue steady. We have added a special curriculum for Medication Assisted Treatment (MAT) for Opioid Disorders (OUD) at Martinez and West County in English and Spanish!

Adolescent Treatment Expansion

Bay Area counties met in July with CalMHSA to consider a Regional Contract with an unidentified provider, this will be taken for consideration to their Board of Directors. In the meantime; The Camp, is applying into Contra Costa's solicitation process to start a small contract. The Camp is not willing to become Drug Medi-Cal (DMC) certified. San Francisco County will also be contracting with The Camp to meet obligations with the State. The contract, when established will be able to serve at least 3 youth on annual basis. AODS will be using Opioid Settlement Funds as advised by the community and will likely cover 30 days per youth, which is the Medi-Cal standard. Sadly, to date, no other provider has submitted a proposal to provide SUD treatment services for youth.

Recovery Residences (RR)

For the month October 2024, Uilkema House had 9 fast-track and 3 regular-track residents. They are all currently engaged in outpatient treatment, employed or seeking employment, and attending self-help meetings. Shelter Inc. received 23 applications; 13 were approved, 2 clients declined services. There were 8 applications that came in at the end of the month that were being processed. Oxford House "McKissick" closed after the house owner chose to sell the home. Oxford House has a total of 57 members in their 6 homes.

Prevention & Opioid Response Efforts

On October 8, the Community Awareness Committee and youth from one of the youth-led AODS prevention programs, Future is Forward, presented a video on cannabis prevention and received a proclamation from the Board of Supervisors proclaiming October 23-31 as Red Ribbon Week. On October 10, AODS had a primary prevention providers training led by DHCS Advance Behavioral Health Prevention California (ABHPC) on the Strategic Prevention Framework (SPF) in preparation for the County Strategic Prevention Plan (SPP) planning. Other efforts to support the Opioid Response by AODS & the CCC MEDS Coalition include: continued collaboration with two local community colleges for current school year, middle and high schools, and expanding Naloxone training to Contra Costa Health programs. A special thank you to AODAB member Roland for his continued advocacy raising opioid education and awareness throughout the County school districts.

CA WIC 5604 and 5963.03—Behavioral Health Boards: Bylaws, Duties, Expenses, Membership

C alifornia's Welfare & Institutions Code (WIC) for local behavioral health boards & commissions includes:

Bylaws (WIC 5604.5)

The local **behavioral** health board shall develop bylaws to be approved by the governing body which shall do all of the following:

- (a) Establish the specific number of members on the **behavioral** health board, consistent with subdivision (a) of Section 5604.
- (b) Ensure that the composition of the **behavioral** health board represents and reflects the diversity and demographics of the county as a whole, to the extent feasible.
- (c) Establish that a quorum be one person more than one-half of the appointed members.
- (d) Establish that the chairperson of the **behavioral** health board be in consultation with the local **behavioral** health director.
- (e) Establish that there may be an executive committee of the **behavioral** health board.

Expenses (WIC 5604.3)

- **(a) (1)** The Board of Supervisors may pay from any available funds the actual and necessary expenses of the members of the **Behavioral** Health Board of a community mental health service incurred incident to the performance of their official duties and functions.
- **(2)** The expenses may include travel, lodging, **child-care** and meals for the members of an advisory board while on official business as approved by the director of behavioral health programs.
- (b) Governing bodies are encouraged to provide a budget for the local **behavioral** health board, using planning and administrative revenues identified in subdivision (c) of Section 5892 [see below], that is sufficient to facilitate the purpose, duties, and responsibilities of the local **behavioral** health board.
- WIC 5892 (c) The allocations pursuant to subdivisions (a) and (b) shall include funding for annual planning costs pursuant to Section 5847 and 5963.03. The total of these costs shall not exceed 5 percent of the total of annual revenues received for the Local Behavioral Health Services Fund. The planning costs shall include funds for county mental health programs to pay for the costs of consumers, family members, and other stakeholders to participate in the planning process ...

Duties (5604.2) and MHSA Duties (5848)

Duties of Boards & Commissions (5604.2)

The local behavioral health board shall: (WIC 5604.2(a))

- Review and evaluate the community's public behavioral health needs, services, facilities, and special problems in any facility within the county or jurisdiction where mental health or substance use disorder evaluations or services are being provided, including, but not limited to, schools, emergency departments, and psychiatric facilities.
- 2. (A) Review any county agreements entered into pursuant to <u>Section 5650</u>. (B) The local behavioral health board may make recommendations to the governing body regarding concerns identified within these agreements.
- 3. **(A)** Advise the governing body and the local **behavioral** health director as to any aspect of the local **behavioral** health program. **(B)** Local **behavioral** health boards may request assistance from the local patients' rights advocates when reviewing and advising on mental health or substance use disorder evaluations or services provided in public facilities with limited access.
- 4. **(A)** Review and approve the procedures used to ensure citizen and professional involvement at all stages of the planning process. **(B)** Involvement shall include individuals with lived experience of mental illness and their families, community members, advocacy organizations, and mental health professionals. It shall also include other professionals that interact with individuals living with mental illnesses on a daily basis, such as education, emergency services, employment, health care, housing, law enforcement, local business owners, social services, seniors, transportation, and veterans.
- 5. Submit an annual report to the governing body on the needs and performance of the county's **behavioral** health system.
- 6. **(A)** Review and make recommendations on applicants for the appointment of a local director of **behavioral** health services. **(B)** The board shall be included in the selection process prior to the vote of the governing body.
- 7. Review and comment on the county's performance outcome data and communicate its findings to the California Behavioral Health Planning Council.
- 8. This part does not limit the ability of the governing body to transfer additional duties or authority to a **behavioral** health board.
- (b) It is the intent of the Legislature that, as part of its duties pursuant to subdivision (a), the board shall assess the impact of the realignment of services from the state to the county, on services delivered to clients and on the local community.

Duties of Boards & Commissions (MHSA)

BHSA Duties from Code Section 5963.03

- (b) (1) The behavioral health board established pursuant to Section 5604 shall conduct a public hearing on the draft integrated plan and annual updates at the close of the 30-day comment period required by subdivision (2) Each plan and update shall include any substantive written recommendations for revisions. The adopted integrated plan or update shall summarize and analyze the recommended revisions. (4) The behavioral health board shall review the adopted integrated plan or update and make recommendations to the local mental health agency, local substance use disorder agency, or local behavioral health agency, as applicable, for revisions. (5) The local mental health agency, local substance use disorder agency, or local behavioral health agency, as applicable, shall provide an annual report of written explanations to the local governing body and the State Department of Health Care Services for any substantive [see (d) below] recommendations made by the local behavioral health board that are not included in the final integrated plan or update.
- (d) For purposes of this section "Substantive recommendations made by the local behavioral health board" means any recommendation that is brought before the board and approved by a majority vote of the membership present at a public hearing of the local behavioral health board that has established its quorum.

Membership (WIC 5604.)

- (a) (1) **(A)** Each community mental health service shall have a **behavioral** health board consisting of 10 to 15 members, depending on the preference of the county, appointed by the governing body, except that **a board in a county** with a population of fewer than 80,000 may have a minimum of five members. **(B)** A county with more than five supervisors shall have at least the same number of members as the size of its board of supervisors. **(C)** This section does not limit the ability of the governing body to increase the number of members above 15.
- (2) (A) (i) The board shall serve in an advisory role to the governing body, and one member of the board shall be a member of the local governing body.
- (ii) Local behavioral health boards may recommend appointees to the county supervisors.
- (iii) The board membership should reflect the diversity of the client population in the county to the extent possible.
- **(B)(i)** Fifty percent of the board membership shall be consumers, or the parents, spouses, siblings, or adult children of consumers, who are receiving or have received behavioral health services. At least one of these members shall be an individual who is 25 years of age or younger.
- (ii) At least 20 percent of the total membership shall be consumers, and at least 20 percent shall be families of consumers.
- **(C) (i)** In counties with a population of 100,000 or more, at least one member of the board shall be a veteran or veteran advocate. In counties with a population of fewer than 100,000, the county shall give a strong preference to appointing at least one member of the board who is a veteran or a veteran advocate.
- (ii) To comply with clause (i), a county shall notify its county veterans service officer about vacancies on the board, if a county has a veterans service officer.
- (D) (i) At least one member of the board shall be an employee of a local education agency.
- (ii) To comply with clause (i), a county shall notify its county office of education about vacancies on the board.
- **(E)** (i) In addition to the requirements in subparagraphs **(B)**, **(C)**, and **(D)**, counties are encouraged to appoint individuals who have experience with, and knowledge of, the behavioral health system.
- (ii) This would include members of the community that engage with individuals living with mental illness in the course of daily operations, such as representatives of county offices of education, large and small businesses, hospitals, hospital districts, physicians practicing in emergency departments, city police chiefs, county sheriffs, and community and nonprofit service providers.
- (3)(A) In counties with a population that is **fewer** than 80,000, at least one member shall be a consumer and at least one member shall be a parent, spouse, sibling, or adult child of a consumer, who is receiving, or has received, mental health **or substance use disorder** services.
- (B) Notwithstanding subparagraph (A), a board in a county with a population that is **fewer** than 80,000 that elects to have the board exceed the five-member mini-

- mum permitted under paragraph (1) shall be required to comply with paragraph (2).
- (b)(1) The behavioral health board shall review and evaluate the local public mental health system, pursuant to Section 5604.2, and review and evaluate the local public substance use disorder treatment system.
- (2) The behavioral health board shall advise the governing body on community mental health services delivered by the local mental health agency or local behavioral health agency, as applicable.
- (c)(1) The term of each member of the board shall be for three years.
- **(2)** The governing body shall equitably stagger the appointments so that approximately one-third of the appointments expire in each year.
- (d) If two or more local agencies jointly establish a community mental health service pursuant to Article 1 (commencing with Section 6500) of Chapter 5 of Division 7 of Title 1 of the Government Code, the **behavioral** health board for the community mental health service shall consist of an additional two members for each additional agency, one of whom shall be a consumer or a parent, spouse, sibling, or adult child of a consumer who has received mental health **or substance use disorder treatment** services.
- **(e)**(1) Except as provided in paragraph (2), **a** member of the board or the member's spouse shall not be a full-time or part-time county employee of a county mental health **and substance use disorder** service, an employee of the State Department of Health Care Services, or an employee of, or a paid member of the governing body of, a mental health contract agency.
- (2) A consumer of **behavioral** health services who has obtained employment with an employer described in paragraph (1) and who holds a position in which the consumer does not have any interest, influence, or authority over any financial or contractual matter concerning the employer may be appointed to the board. The member shall abstain from voting on any financial or contractual issue concerning the member's employer that may come before the board.
- (f) Members of the board shall abstain from voting on any issue in which the member has a financial interest as defined in Section 87103 of the Government Code.
- (g) If it is not possible to secure membership as specified in this section from among persons who reside in the county, the governing body may substitute representatives of the public interest in mental health who are not full-time or part-time employees of the county mental health service, the State Department of Health Care Services, or on the staff of, or a paid member of the governing body of, a **behavioral** health contract agency.
- (h) The behavioral health board may be established as an advisory board or a commission, depending on the preference of the county.
- (i) For purposes of this section, "veteran advocate" means either a parent, spouse, or adult child of a veteran, or an individual who is part of a veterans organization, including the Veterans of Foreign Wars or the American Legion.

BHSA: Stakeholder Involvement Requirements (Beginning January 1, 2025)

Each Integrated Plan (3 Year Plan) must be developed with local stakeholders. Counties must demonstrate a partnership with constituents and stakeholders throughout the process that includes **meaningful stakeholder involvement** on mental health and substance use disorder policy, program planning, and implementation, monitoring, workforce, quality improvement, health equity, evaluation, and budget allocations.

Integrated Plans should include a demonstration of how the county will utilize various funds for behavioral health services to deliver high-quality, culturally responsive, and timely care along the continuum of services in the least restrictive setting from prevention and wellness in schools and other settings to community-based outpatient care, residential care, crisis care, acute care, and housing services and supports.

STAKEHOLDERS:

- **I.** Each Integrated Plan (3 Year Plan) must be developed with local stakeholders, including, but not limited to, all of the following:
 - 1. Adults and older adults who either:
 - a. Meet the criteria to receive specialty mental health services or
 - b. Have a substance use disorder
 - 2. Families of individuals (all ages) who meet the criteria to receive specialty mental health services
 - 3. Youths or youth mental health or substance use disorder organizations
 - 4. Providers of mental health services and substance use disorder treatment services
 - 5. Public safety partners, including county juvenile justice agencies
 - 6. Local education agencies
 - 7. Higher education partners
 - 8. Early childhood organizations
 - 9. Local public health jurisdictions
 - 10. County social services and child welfare agencies
 - 11. Labor representative organizations
 - 12. Veterans
 - 13. Representatives from veterans organizations
 - 14. Health care organizations, including hospitals
 - 15. Health care service plans, including Medi-Cal managed care plans as defined in subdivision (j) of Section 14184.101
 - 16. Disability insurers
 - 17. Tribal and Indian Health Program designees established for Medi-Cal Tribal consultation purposes
 - 18. The five most populous cities in counties with a population greater than 200,000
 - 19. Area agencies on aging
 - 20. Independent living centers
 - 21. Continuums of care, including representatives from the homeless service provider community
 - 22. Regional centers
 - 23. Emergency medical services
 - 24. Community-based organizations serving culturally and linguistically diverse constituents
- **II. Diverse Viewpoints Required**: Counties must include sufficient participation of individuals representing diverse viewpoints, including, but not limited to:
 - 1. Representatives from youth from historically marginalized communities
 - 2. Representatives from organizations specializing in working with underserved racially and ethnically diverse communities
 - 3. Representatives from LGBTQ+ communities
 - 4. Victims of domestic violence and sexual abuse
 - 5. People with lived experience of homelessness

SUPPORTS & REQUIREMENTS

- 1. **Training and Technical Assistance**: A county may provide supports, including, but not limited to, training and technical assistance, to ensure stakeholders, including peers and families, receive sufficient information and data to meaningfully participate in the development of integrated plans and annual updates.
- 2. **Description of the Stakeholder Process & Input:** Integrated plans (3 Year Plans or Annual Updates) must include:
 - a. A description of the development process in partnership with local stakeholders;
 - b. Consideration of input and feedback into the plan provided by stakeholders, including, but not limited to, those with lived behavioral health experience, including peers and families;
 - c. A description of how the integrated plan aligns with local goals and outcome measures for behavioral health, including goals and outcome measures to reduce identified disparities;
 - d. *A demonstration of how the county has considered other local program planning efforts in the development of the integrated plan to maximize opportunities to leverage funding and services from other programs, including federal funding, Medi-Cal managed care, and commercial health plans. (*Beginning July 1, 2026)
 - e. Certification by the county behavioral health director, that ensures that the county has complied with all pertinent regulations, laws, and statutes, including stakeholder participation requirements.
- 3. **30-Day Review:** A **draft** Integrated 3-Year Plan or Update must be prepared and circulated for review and comment for at least 30 days to representatives of stakeholder interest and any interested party who has requested a copy of the draft plan.
- 4. Local Behavioral Health Board/Commission (BHB) Requirements: The BHB must:
 - a. Review & approve procedures used to ensure citizen & professional involvement in all stages of planning process;
 - b. Conduct Public Hearings on the **draft** Integrated 3-Year Plans or Updates at the close of 30-day public comment periods.
 - c. Review the **adopted** Integrated 3-Year Plans or Updates & make recommendations to the local mental health agency, substance use agency or behavioral health agency, as applicable, for revisions;

5. ADOPTED Integrated Plan Requirements

- a. Each adopted integrated plan and update shall include substantive written recommendations for revisions.
- b. The adopted integrated plan or update shall summarize and analyze the recommended revisions.
- c. The local MH/BH agency must provide written explanations in an annual report to the governing body and DHCS for any "substantive recommendations made by the BHB" that are not included in the final plan or update. "Substantive recommendation made by the local behavioral health board" means a recommendation that is brought before the board and approved by a majority vote of the membership present at a public hearing of the local behavioral health board that has established a quorum.
- d. *Each county's board of supervisors shall approve the integrated plan and annual updates by June 30 prior to the fiscal year or years the integrated plan or update would cover. (*Beginning July 1, 2026)

Proposition 1: Modernization of Mental Health Services Act

- Passed in March 2024
- Requires all counties to have a combined Behavioral Health Advisory Board beginning 1/1/25
- Restructures the Mental Health Services Act (MHSA) also known as "millionaire's tax"
- Focus on Housing and related services, Intensive Wraparound Care (Full-Service Partnerships)
- Allows expanded use of MHSA funds to include Substance Use Disorder (SUD) services, in addition to Mental Health care.
- MHSA becomes Behavioral Health Services Act (BHSA)
- Full implementation to begin with the 2026-29 Three-Year Plan (7/1/26)



Membership

The Behavioral Health Board will Consist of:

- 10 to 15 members
- 50% consumers, or the parents, spouses, siblings, or adult children of consumers
 - One of these members will be 25 years of age or younger
- 20% will be consumers
- 20% will be families of consumers
- · One member will be a veteran or veteran advocate
- One member will be an employee of a local education agency
- Term of three years
- Appointments will be staggered



Membership cont.

Exceptions:

- Member of the board, or their spouse, shall not be a county employee of a county mental health or substance use disorder service, an employee of the State Department of Health Care Services (DHCS), or an employee, or paid member, of the governing board of a mental health or substance use disorder contract agency
- Exception: a consumer of behavioral health services who has obtained employment in any of the above and holds a positions in which the consumer does not have an interest, influence, or authority over a financial or contractual matter shall
 - abstain from voting on a financial or contractual issue concerning the member's employer





Functions will include:

- Review and evaluate the local public mental health system
- · Review and evaluate the local public substance use disorder treatment system
- · Advise the governing body on community mental health and substance use disorder services
- Review and evaluate the community's public behavioral health needs, services, facilities, and special problems where services are being provided
- Review county agreements
- Advise the governing body and the local behavioral health director
- Ensure citizen and professional involvement at all stages
- Submit and annual report
- · Review and recommend appointment of the local director of behavioral health services
- Review and comment on county's performance outcome date
- Assess the impact of the realignment of services
- Conduct a public hearing on the draft three-year program and expenditure plan and annual updates at the close of the 30-day comment period required by subdivision.
- Review adopted BHSA plan and make recommendations to the local behavioral health agency.
 - Provide an annual report of written explanations to the local governing body and DHCS





Development of bylaws include:

- A specific number of members
- Quorum be one person more than one-half of members
- Establish the chairperson of the behavioral health board be in consultation with the local behavioral health director
- Establish that there may be an executive committee of the behavioral health board

Donnie, a father of two, would tell anyone that he's had quite a life journey (so far). Here, he waxespoetical about highlights.


Please tell us about yourself.

Let's see here. What can I say right now...Okay. Before I got here, I was my lifestyle, which I thought was a good one. I sold drugs, I went to prison, and then I was managing a strip club in San Francisco. That whole culture, that whole lifestyle, was very toxic, but I didn't realize it.

I didn't think about it at the time, until when my daughter made art for Father's Day. I looked at it and I said [to myself], "I got to stop doing that. That represents everything I'm trying to keep away from my daughter."

When I moved out here to Contra Costa County is when I actually went into treatment. When I went to Discovery House, an alcohol and drug rehab center in Martinez, that actually changed my life. From there, I became more focused, I let that life go, and I learned a lot about myself.

During that time, I realized that all the pain and



to endure those in order for me to be prepared for the next stage in life. With that being said, it doesn't make all the pain go away, but what it does to me gives the pain a purpose. Does that make sense?

Yeah, it does. Going back to the picture, what did your daughter draw?


It was a collar shirt with a tie that she colored in—very cute. It had these sentences that I think were prewritten, and her teacher would ask her questions and she would answer it. It said, "I love my daddy because, and then he plays with me. My daddy is very nice." Then she said, "My daddy works selling tickets for people who want see movies."

That's what bothered me, because she thought I was working at the theater, which actually was The Mitchell Brothers Theater. It's not movies, it's a strip club. There were movies there, but they were adult videos. I felt I was deceiving her. I didn't want her to grow up embarrassed of what her dad does. I love my daughter too much to deceive her in that way. So I had to leave it. It was very hard.

Regarding Discovery House, what did you learn about yourself while you were there?

It was April 19, 2019. Iremember that day, because that's when I started my journey back in recovery and letting go of the past. I remember before I walked into Discovery House, I stopped because I was scared of death. I never knew a life without the drugs or somewhere in the underworld. That was what I lived with and lived in for so long, that it was all normal for me.

I thought to myself, if I walk through those doors, I can never have another drug again in my life. That bothered **CONTINUES ON PAGE 2**

me. That scared the hell out of me. But I figured I had to do it because of my daughter. I didn't like the person I was at the time. I felt that it all had to stop and I couldn't do it by myself.

At Discovery House, I learned that recovery and getting off the drugs is simple, but it's not easy, because you only have to change one thing and that one thing is everything. When I heard that and I accepted that, it's when things started to make sense and started to change for me. I learned that things aren't always about me.

At one time, I felt that I was like the sun and the world revolved around me. I was very ego-driven. Going into its treatment program gave me tools and then it sparked something in me. I graduated from Discovery House and was elected member of the board of its alumni association. I was accepted into the SPIRIT Program* at Contra Costa College.

I learned a lot about motivational interviewing. I learned a lot about case management and active listening. I also learned a lot about myself and how to deal with people, because it's going into [jobrelated] fields that involve dealing with people. I have to make sure that I leave my judgments and my expectations at the door, because you never know what's going to happen. You never know who's going to come through the door.

When I completed that program, the fire was lit from under me. And I laughed because who would've thought, a couple years ago when I was dealing drugs and in the sex entertainment industry, that my focus and my passion would be in the business of healing? I never would've believed it.

If you could describe yourself in one word, what would that word be?

"Motivated," because I know now that I have a burpose. My life actually has a purpose. When

don't want to go back to. It motivates me to keep going forward and then also to try to chase the feeling of that empowerment. When I see that, it makes me feel almost electric.

What does the saying, "Get back on one's feet," mean to you?

To get back on my feet is knowing that all the struggles and obstacles and pain are necessary. That's growth. Where you grow is when you face those things. When you do something that you've never done before. Either you can commit to constant growth and face discomfort on your own accord and be the master of your own destiny, or you can hand over the keys and let life happen to you by default.

It's your choice. One leads to success, the other leads to pain and struggling. And I know that now. I'm capable of returning and getting back on my feet, because the storms and fires inside of me are stronger than the storms outside of me. I'm capable as long as I do the work. I understand that I can't just wait for it to happen, I've actually got to make it happen. Also, reaching out and asking for help, which is something that I wouldn't do before because I thought it was weak. Now, I'm open to all the resources and help that are available. Everything that's available to me, I'll take advantage of it.

What motivates you to keep going even on days or weeks or months when things are not going your way?

That's an interesting question, because I also suffer from depression, anxiety, and PTSD. Sometimes, it gets really heavy. With those days where I feel it's not productive or it's not working for me, I tend to isolate. I would isolate, which I know is not what you should do, but it's one of my coping skills. I find some alone time. Understanding that it's all happening for a reason

questioning their faith and their commitment,

My thing is, will I still stay true to my commitment, even though the mood that I set it in is gone? So, I just remember [my commitment to myself]. Yes, it's hard. Yes, it's tough. But it's necessary, and it's learning. That's where the growth is.

What advice would you give to individuals who are about to reenter society?

You're kidding yourself if you think it's going to be sunshine and rainbows the moment you get out. You got to understand that it's going to take a while. It's going to take time, but you have to focus on keeping your eyes on the prize, knowing what you're doing it for. You have to have a goal—a reasonable goal.

Don't get discouraged; you have to have faith in yourself. I don't care how tough you are in prison, I don't care how strong you are, or how hard you hit. There's nothing that's going to hit you harder than life. Life will beat you down and bring you to your knees if you let it.

If you know what you're worth, then go out and get what you're worth. Take accountability for what you've done, and just know that it's possible. It's possible. That's why I put a lot of emphasis on these programs. It's because they work.

Coming out of the prison system, when asking for help is almost like a sign of weakness—it's not weak, it's actually more of a strength. Say, "Hey, can you help me with this?" Or, "I need help with that." That pushes you forward towards your goal of where you want to be.

It might not be a huge step, but you have to celebrate small victories. Everybody has a purpose. Everybody, whoever they are, they matter. They're important. There's no substitute for work. That is the price you pay for success.

of got into recovery and started living a life of sobriety and healing and helping others, that's what motivated me. In my past, I would always follow the high from the drugs or the strip club, but now I get that feeling when I work with somebody, when I see it in their eyes, when everything just clicks.

At that moment they have hope; they're not so lost. They actually look forward to the day in front of them, the light at the end of the tunnel, the way out. Their spirit is no longer broken. When that happens, when I see that, I get the chills, and that's the feeling I get from recovery.

I learned you can't keep it unless you give it away. So helping people heal also helps me. It helps me in my journey because it reminds me of my struggles and what I

can't rush it.

Igotta actually trust it—I can't get to a five-year destination overnight. There are steps involved in the process. Many times I come across those days where I just say, "Man, why am I doing all this? What's it all for?" And then something brings me back to when I made my commitment.

Not every day is going to be motivated or motivational. Just like when people start a new hobby or whatever, they're on fire, they're excited, they're motivated, but somewhere along the way, something starts slowing down, starts

is, you got to put in the work. It depends on how bad you want it. You can do it absolutely 100 percent. Reach out to those people who will help you get you to the next level. If you want to change, you only got to change one thing. And that's everything.

*SPIRIT is short for Service Provider Individualized Recovery Intensive Training, a 9-unit course taught in collaboration with Contra Costa Behavioral Health Services.
