WHEREAS

Description: Contra Costa County on June 13, 2023 contracted with Bay Cities Paving & Grading, Inc. for work generally consisting of pavement dig outs and base failure repairs in the unincorporated Bay Point, Lafayette, Pacheco, Contra Costa Centre areas, and Kirker Pass Road. Work in the Bay Point Area (Site 1) included mill and overlay with placement of thermoplastic striping and markings on North Broadway. Work in the Pacheco Area (Site 2) included mill and overlay with placement of thermoplastic striping and markings on Concord Avenue. Work in the Lafayette Area (Site 5) included mill and overlay of three cul-du-sacs; Jennifer Highlands Ct., Dana Highlands Ct., and Julie Highlands Ct. Work in all areas also included placement of temporary paint striping, pavement failure repair, and traffic signal loop installation, all in accordance with the plans, drawings, special provisions and/or specifications prepared by or for the Public Works Director and in accordance with the accepted bid proposal. The project was located in the Bay Point, Pacheco, Contra Costa Centre, Kirker Pass, and Lafayette areas, with the Travelers Casualty and Surety Company of America, as surety, for work to be performed on the grounds of the County; and

The Public Works Director reports that said work has been inspected and complies with the approved plans, special provisions and standard specifications and recommends its acceptance as complete as of December 21, 2023.
