I'm Pete Caldwell, Executive Director of We Care Services for Children and I appreciate the opportunity to provide public comment regarding Measure X funding choices.

We Care has been providing Early Childhood Developmental and Mental Health services in Contra Costa County for over 60 years and has long been an advocate for greater community understanding of the significant value of the types of early intervention our most vulnerable neighbors need.

The promise of Measure X funding has been in its community-sourced understanding of the deep need for early childhood funding as a way of addressing the most fundamental deficits in this county's support net. To date, less than 4% of Measure X funds have targeted what research shows is the most impactful time to intervene in a child's development.

In Contra Costa, a likely 10,00 children have a diagnosable Mental Health concern and the gap between the needs and the resources available to effectively address them has only widened. The recent implementation of CalAIM has further impacted families' access to critical services as providers like We Care are no longer reimbursed for travel to home visits - crucial to effective intervention.

On behalf of the children and families left behind, and the opportunity missed for a healthier community, I ask that the Board make a commitment to the future of this county by addressing the need that exists today for greater funding for Early Childhood Services

We offered a place to get COVID shots, food bags, clothes, and many more items families needed during this time. I know what the benefit of a Wellness Hub could be for my community. My lived experience and focus is to uplift African American men who have faced many obstacles dealing with, depression, anxiety, and suffering from the passing of loved ones. My mom passed away 23 years ago from a heroin overdose which was a plague in the city of Oakland. I lost my brother 4 years ago from a sickness which ended up going sepsis and he passed from septic shock. I lost my uncle a year ago, from cancer which could have been treated had he gone to the doctor sooner. We need a place where we can go and get resources and treatment Holistically. This facility should be operated by African Americans, someone that look like us. I need a place to go and sit with someone who has lived experiences that can relate and look like me. There have been trust issues with doctors since the Tuskegee syphilis study. Please consider finding a place in Antioch as the main Hub and then planting other satellite hubs throughout our county.

TO THE BOARD OF SUPERVISORS:

I am writing as an African American resident of Bay Point, CA, and mental health professional in Contra Costa County for over 40 years, to support NAMI of Contra Costa in establishing an African American Wellness Hub in Contra Costa County. The headquarters of the Wellness Hub should be in Antioch, which receives very few county services. I have appeared before the Board of Supervisors on several occasions to voice the effects of historical and current systemic racism within the health care system and the need for such a Wellness Hub. With the high rates of health disparities in the Black community, occurrence of mass shootings nationally, and indiscriminate shooting of unarmed Black men locally, there is an urgent need for increased mental health services for individuals, families, people incarcerated, and our youth. All of us are traumatized by these events and the uncertainty of harm we face every day. At the last meeting of the Board of Supervisors we were told there may be \$80,000 allotted to do conduct a feasibility study of the need for the African American Wellness Hub.


After that meeting I had an emotional meltdown from hearing myself and other colleagues pour our hearts out citing lived experiences of grief and trauma and asking for help. It was mind boggling to me that after all the data nationally and locally which shows the Black community is the most harmed by the systemic neglect and abuse of the health care industry in America, the only remedy offered was a "feasibility study"! I came away from that meeting feeling like a beggar pleading for help and that the Supervisors did not care!

I personally know there are enough Black health care professionals and allied health staff (active and retired) available to staff and operate an African American Wellness Hub with centers in West and East County. The only primary needs to make the Wellness Hub a reality are a physical space in East and West county and funding to cover the cost of staffing. I sincerely hope a timely decision is made to establish the Wellness Hub, until then I will continue my efforts to help those I can and keep the Black community informed that our pleas for help are being "studied".

My name is Jeralynn Brown-Blueford. I am writing this letter to express the deep anguish, agony, and distress I feel as an African-American Mother, Grandmother, and Employee within Contra Costa County. I am grateful and appreciative of the funding for the feasibility study, however with all honesty I don't feel it is enough funding to support the needs, or demands that are needed for our African American Community. I am being truly transparent when I say; that there is NO need to study the widely known facts backed up with data detailing the truth about African Americans being the most undervalued, overlooked, and mistreated in most county-led agencies.

I would like to share my perspective and feelings as a Mother, Community Chaplain, and concerned Employee of Contra Costa County. The African-American Community has several reasons (as data shows) to feel that there is no need for this study. We know the results of not having suitable healthcare, affordable housing, proper education, and safe schools. We know what it is to not have public trust in our judicial system and police departments. Families like mine have first-hand experience with Antioch Police Officer's racially motivated text messages. My family knows firsthand their discussions about falsifying evidence and beating up suspects (My Son was beaten up very badly by APD). We know firsthand how they were making homophobic remarks and using sexually explicit language in 2020 and 2021. My Son had experienced all of this with the APD, in February 2020.

My Son suffered PTSD, Depression, and anxiety from the murder of his younger brother at the hands of an OPD Officer. My Son was accosted by two APD officers while walking to his car from the convent store. He said, "The APD officers called him the "N" word, and other racial despairing names. When he asked them why they were harassing him, "they said because you looked suspicious. "He asked, "Suspicious or black?" The response was, "Both". They asked him for his identification, and when he bent down to retrieve it from the middle compartment of his car they jumped on him and began, punching him. He was hit in the head with a service pistol so many times, the handle broke. He was screaming, "Kill me, kill me, like you did my brother." They arrested him and called for an ambulance to attend to his bleeding skull. While inside the ambulance one of the APD officers contained the name-calling, pulled out his cell phone, and began showing him pictures of dead bodies. My Son had a complete mental breakdown after this experience. My Son was arrested for resisting. Nobody listened to him when he shared his experience in court, the prosecutor never investigated what the officers from pursuing or securing criminal convictions or sentences based on race, ethnicity, or natural origin.

I am writing this letter to express the deep pain I feel as an African American resident in this county. I am appreciative of the funding for a feasibility study, however, I do not feel it's enough and in true transparency, there is no need to study a widely known fact that is backed up by data that African Americans are the most harmed and neglected in county-led systems.

I've had my share of experiences being a victim of racism and a victim of having family with mental health issues been treated wrong by law enforcement and by judges with a lack of experience dealing with individuals with mental health issues. I am writing this letter to express the deep pain I feel as an African American being employed in Contra Consta County and having family members who reside in this county.

First, I am appreciative of the 80K funding for the feasibility study; however, I am discouraged that a study needed to be done in the first place. Clearly the data shows that African Americans only make up 9% and of the 9% a third 1/3 end up being booked in county jail and over 26% are charged with criminal cases of the 9%. 41% make up the juvenile probationers. This is very alarming while BIPOC communities are the most affected when it comes to incarceration, homelessness, mental health, and killings by Police. Truely a feasibility study did not need to happen when the data clearly lets us know African Americans are the most harmed.

Again, it saddens me that when other nationalities request funding for improvement in areas where they're concerned there is a lack or need.
