December 10, 2024

1. Call to Order 6:02 p.m.

Board Members Present: Ron Banducci, Robert Durr, Bruce Gekko, Linda Kralik, Bill Lipsin, Linda Vaughn, Dr. Vin Mathur(alternate). Absent: Andy Cohan

County Reps: Supervisor Candace Andersen, Jeff Schultz (Blackhawk Police Chief), Tyler Hahn (CHP), Carol Mascali (Supervisor Andersen office).

Residents and guests present: Andrew Konieczny (HOA).

2. Public Comments: none.
3. Recognition & acknowledgement of community service by outgoing P2A members.
4. Reviewed November draft record of actions: Ron Banducci moved; Linda Vaughn seconded.
5. Chief of Police Report from the previous month's activities (November 2024)
 - a. 383 calls; 17 reports; 5 felonies; 4 misdemeanors; 4 arrests.
 - b. The felonies were:
 - i. Two vehicles were broken into while parked in the Blackhawk Plaza parking lot. Both break-ins happened within minutes of each other. Their rear windows were smashed, and items were removed from the backseat. The break-ins occurred in areas not covered by surveillance cameras.
 - ii. Two residents reported being the victims of identity theft.
 - iii. A grand theft occurred in the Plaza parking lot where a victim had left his vehicle unlocked with his wallet and cell phone on the center console. The value of items exceeded \$950
 - c. The misdemeanors included:
 - i. A battery took place between two adult males at a residence. Both parties were separated however the suspects had left the residence prior to deputies' arrival.
 - ii. Deputies responded to a domestic disturbance at a residence. The husband was arrested for battery against his wife. He was transported to the Martinez Detention Facility (MDF).
 - iii. Deputies responded to the same residence, as above, for a violation of a domestic violence restraining order. The husband was arrested again and booked at the Martinez Detention Facility.
 - iv. An adult male crashed his golf cart into a bunker on the Falls golf course. The male was arrested for driving under the influence and booked at the MDF.
 - d. There were four arrests – three were for the above misdemeanors; one was for an adult female for a warrant during a suspicious persons call after she had entered the community on foot. The woman was transient.
 - e. No significant incidents of interest to report.
 - f. Volunteers in Policing: 18 hours served by four volunteers.
 - g. There will be no "Coffee with the Chief" for December.

6. Blackhawk Police Staffing Plan
 - a. Chief Schultz will be refreshing the staff to add two new deputies in January 2025. We may be running short-staffed for a period since our current 3 deputies will be leaving January 13th. Chief Schultz will be having some officers provide coverage through overtime.
7. HOA report: none.
8. Blackhawk Country Club report: none.
9. CHP report:
 - a. Over 2900 crashes YTD – 330 on county roads (1/month on Blackhawk Rd; 1.5/mo. on Tassajara); the remainder on the highways. There were 13 fatalities reported YTD.
 - b. 146 DUI crashes/640 DUI arrests YTD
 - c. 13 fatalities YTD

Summary for December 2024

The Blackhawk and Valley Station Deputies either initiated or responded to the following calls for service:

- 369 ~ Total calls for service in Blackhawk
- 7 ~ Total police reports were taken in Blackhawk

Felonies - There were no felonies reported in the district.

Misdemeanors - There was 1 misdemeanor committed in the district.

1. On 12/24/24, a hit and run accident occurred at the intersection of Blackhawk Dr. and Hickory Ct. The suspect rear ended the victim's vehicle while it was stopped at the stop sign. The suspect fled the scene prior to exchanging information with the victim and police arrival. CHP handled the original report; however, Blackhawk Police Services is also investigating and has identified the responsible.

Arrests – There were no arrests for the month.

Incidents of Interest

- There were no significant incidents of interest during the month.

Volunteers in Policing

- Our four volunteers provided 18 hours of volunteer work throughout the month. The volunteers provided their routine security checks, patrol vehicle presence and numerous Vacation House Checks.

Notes from the Chief of Police

- With the beginning of the new year comes a shift change within the Office of the Sheriff. Due to this shift change, Blackhawk Police Services will see a significant change in personnel beginning January 13th. As many already know, Blackhawk Police Services staff consist of 1 Sheriff's Department Lieutenant (Chief) and 3 deputies.

Two of the three deputies currently assigned to Blackhawk have completed their commitment to the district and have been reassigned to other divisions/jurisdictions within the Sheriff's Office. This is common for deputies seeking further career development and experience, after a couple of years of service in the district. Our third deputy resigned from the Sheriff's Office and took a position as a police officer at a department much closer to his hometown, for quality-of-life benefits.

At this time, two deputies have been selected as replacements and will begin working in the district on January 13th. Coming soon will be an edition of the "Blackhawk Beat," which will introduce our newly assigned deputies and provide some information on each.

Unfortunately, due to staffing levels within the Sheriff's Office I am unable to fill the third deputy position at shift change. This vacancy will be filled utilizing overtime, so to be sure the district is covered as if it was fully staffed. I am cautiously optimistic I will be able to fill this third spot within a few months. I will elaborate more on this in the upcoming "Blackhawk Beat" as well.

- The Blackhawk Police Advisory Committee meetings will once again be ZOOMED, for those wishing to attend remotely. The ZOOM option will begin at our next meeting, occurring Tuesday, January 14th. The link to join the meeting will be in the agenda, sent out from your homeowners associations preceding the meeting. It can also be accessed through the county's website, under committee meetings.
