P.1. Presentation by Contra Costa County Supervisor's Office

Updates were provided on traffic safety improvements following recent site visits in East Richmond Heights and San Pablo Heights. Public Works is exploring low-cost enhancements at key intersections. The County's Noise Ordinance Task Force will reconvene on June 3. A report of multiple bird deaths along Bernhardt Avenue was shared; the matter is under investigation by the County Sheriff's Office. Open seats on District 1 advisory boards and commissions were announced and residents were

encouraged to apply. A question was raised regarding access to platforms like Nextdoor and Craigslist to help report backyard breeding. Ronnie Mills will coordinate with Supervisor Gioia's office to identify any contacts that can assist. Updates were also provided on the recent passing of a local community member, with condolences extended on behalf of the Council.

P.2. Presentation by Sheriff's Office Bay Station Commander, Lt. Brian Holland

Lieutenant Brian Fitzgerald introduced himself as the new Bay Station Commander. He reported five calls for service in April, including two runaway juveniles and one identity theft. Investigations are ongoing into bird fatalities, with PG&E inspecting nearby infrastructure. Residents were also reminded of continued issues with catalytic converter thefts and early firework activity.

P.3. Presentation by Contra Costa County Fire Protection District, Michelle Rinehart

Michelle from the Fire Protection District provided updates on Local Responsibility Area (LRA) fire hazard maps and upcoming wildfire preparedness activities. Contractors have been selected to address non-compliant parcels ahead of abatement deadlines. Ongoing wildfire mitigation efforts include shaded fuel breaks and prescribed burns. The success of the County's mitigation program and the usefulness of the online project portal were also noted. The benefits of pursuing Firewise community certification were discussed, particularly in relation to homeowner insurance eligibility. Michelle clarified that while Firewise recognition does not guarantee coverage, it supports broader efforts to protect lives and property. The importance of fuels reduction and community education was emphasized. A panel discussion to explore insurance and Firewise program planning is being considered.

P.4. Presentation by California Highway Patrol (tentative)

Officer Zeid provided an update on CHP activity in the East Richmond Heights area for the month of April. The department responded to six traffic collision reports, one of which involved a major investigation; the remaining incidents were non-injury property damage. Three vehicles were either stored or impounded. CHP also handled two calls for service, one related to a DUI and another involving a pedestrian, as well as a separate traffic hazard. One stolen vehicle report was also filed. Additionally, Officer Zeid confirmed that the CHP has signed and approved the festival permit, which should be returning to the Council shortly.

5. Discussion Items

An update was shared on the East Richmond Heights Community Festival. The event permit was approved quickly, and coordination with vendors is underway. Festival branding materials, including a flyer and banner, are being designed by local partners.
