Qualifications and Volunteer Experience

Please explain why you would like to serve on this particular board, committee, or commission.

I founded my local nonprofit organization, ROAR (Resources for Older Americans and Retirees) three years ago as the result of my extensive professional work serving the needs of older adults - with keen awareness for the fast-approaching surge in California's 65+ population and the particular impact within our county. ROAR is currently multi-campaign with our ultimate goal for every community to become Age-Friendly by 2030. For example, in Discovery Bay, we recently launched a 'Chamber Challenge', partnering with the Chamber of Commerce to conduct an Age-Friendly Community Walk Audit of every street in town. From this, we will compile our data and suggestions and present it to the DB CSD and BOS for consideration and implementation. In 2023, ROAR has provided an average of 527 aging referrals per week. We assist families in planning for financial sustainability, build ADUs for older adults in/at homes in Far East County, and we are currently developing a 90-unit low-income senior housing project on the Delta. ROAR wants to be of service in creating Age-Friendly communities by 2030!

I have been a licensed fiduciary for 17 years, routinely appointed and trusted by the Contra Costa County Superior Court to manage the best interests of order adults, provide for their care, for their estates, and protect them from abuse. Since 2011 I have been a member in good standing with PFAC (Professional Fiduciary Assoc of California), and each year attend conferences and earn ECE units to maintain my license. ROAR holds the CoCo County EHSD contract to provide financial services for clients of the Dept of Aging, Adult Protective Services Bureau, and I have recently been appointed to two County oversight commissions on aging/elder abuse. Through our contract with CCC EHSD, I am appointed cases, typically vulnerable workers who identify or receive information about an order adult struggling to sustain themselves or may be potential victims of elder financial abuse.
