- Reviewed a list of suggested topics for 2026, including the Master Plan for Aging, Monument Crisis Center, Trinity Center, St. Vincent de Paul, and the California Senior Legislature.
- Discussed inviting prior presenters to return, including Contra Costa Housing Authority, Justice in Aging, Hope Solutions, the California Association of Realtors, and Health, Housing, and Homeless Services (H3).
- Discussed an onsite meeting in March to plan priorities for 2026.
- Considered holding a potential onsite meeting at Monument Crisis Center or Trinity Center.

January 31	Deadline for 2-year bills to pass in first house
February 20	Bill introduction deadline
March - April	Policy bill hearings in first house
May	Appropriations hearings
May 29	Deadline for bills to pass in first house
June	Policy bill hearings in second house
July	Legislative summer recess
August	Appropriations hearings
August 31	Deadline to pass bills onto the Governor
September 30	Deadline for Governor to sign/veto bills
