Overview of Measure X Funds

"to keep Contra Costa's regional hospital open and staffed; fund community health centers, emergency response; support crucial safety-net services; invest in early childhood services; protect vulnerable populations; and for other essential county services."

- \$12.8M for alternate destinations/behavioral health facilities

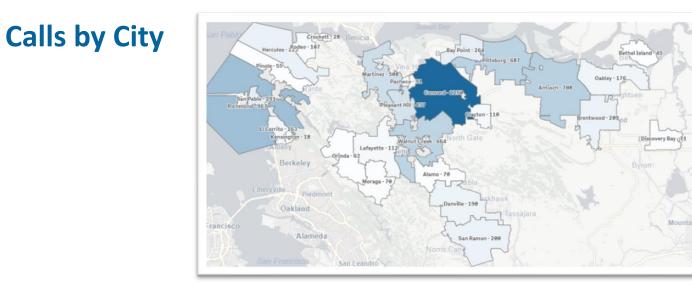

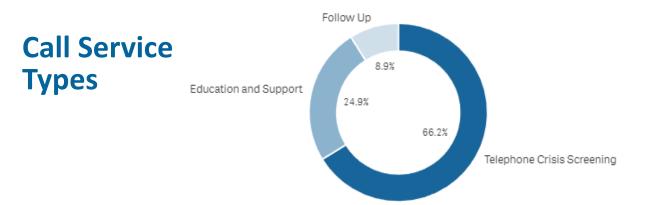

- Covers ongoing & increasing expense of clinical staff
- Provide critical services to the most vulnerable members of our community

\$3.25M one-time funding for maintaining core services

- Expended \$972,424 rolled-over funds in FY 23/24
- 10% COLA (in FY 22/23) for
 29 community-based organizations providing children's mental health services
- Able to draw down match dollars

El Portal Place in San Pablo

- \$5.2M Measure X funds
- Opened 54 units of permanent housing in Aug 2024
- Expect HUD to fund operating & supportive services cost ~\$1.1M/year

- Expect to be fully occupied by Dec 2024

- Over 55,000 visits for 10,989 people in Contra Costa County since 2015
- All CARES enrollees eligible for Medi-Cal as of Jan. 1, 2024

- Opened 54 units of permanent supportive housing
- A3 community crisis initiative operating 24/7 & increasing capacity
- Expanding mental health care for youth & LGBTQ+
- Evaluate sites for future medical, behavioral health & interim housing facilities
- Construction projects, including Martinez campus & Oak Grove
- Returned funds from CARES program
