FY24-25 CSB HEAD START PROGRAM ANNUAL REPORT

CHILDREN & FAMILIES SERVED

Served over 3,000 children and families in FY 24-25

- Up 5% from the prior program year

Maintained 100% monthly enrollment from March through June

Of the 13,000 children living in the county, CCC Head Start only serves 12%.


FAMILY SUPPORT & HOUSEHOLD IMPACT

- Nearly 70% of enrolled children received medical and dental exams
- Over 80% of parents participate in at least one program service
 - Medical and oral health education
 - Financial education
 - Parent Curriculum

SCHOOL READINESS

Kindergarten readiness is tracked with DRDP (Desired Result Developmental Profile) across four age groups, assessed three times yearly to measure growth.

- Average rate increase by 31%



PROGRAM FUNDING

- FY24-25 Head Start funding was provided through Year 1 of a five-year grant (2024-2029), covering September 2024-June 2025, and is 100% publicly funded.
- Most recent Single Audit conducted by the Secretary reported no findings



IN CLOSING

- FY 24-25 showed strong growth, even with enrollment initiatives we were still able outperform our benchmarks
- Child outcome data validate the program impact on children
- As community need remains high, we are committed to continuing to expand our reach and impact
