West County Senior Nutrition RFP – The RFP was published on 8/7/2025. The Bids were due on 8/26/2025. Several bids were received and are being reviewed by Fiscal. Assuming more than one bid passes Fiscal Review, a Program Review Panel will meet Tuesday, 9/23 at 11:15 am (tentative). Recommendations will be forwarded to Tracy Murray, The Director of Aging and Adult Services, for a final decision.



10:30 Committee Reports

- > Membership & Nominating Committee Jill Kleiner
- An Orientation for new ACOA members was held on 8/27/2025. Several excellent new members are eager to participate in the ACOA's work.
- Gerry LaLonde-Berg was interviewed and recommended to the Board of Supervisors as Alternate #3.
 - Holly Frates was recommended to be promoted from Alternate #3 to MAL #9.
 - Teresa Wright was recommended as Alternate #4.
 - Six city seats are currently vacant and Moraga will be vacant soon.
 - A Clayton member is being appointed.
- Nominating Committee Kathryn Monroy-Dexter is the chair. Some people have already expressed interest in the Officer roles.

> Planning Committee – Jill Kleiner

- A focus group revisitation presentation in Oakley is being scheduled.
- Scheduling quarterly site visits to community agencies. The first one will be to Choice in Aging. Space is limited. Sign ups will occur at the General meeting.
- The Committee reviewed a draft of their Annual Report. Committee Chairs will receive a full copy of last year's report as reference. Drafts from each Committee are due back to the Planning Committee by November 15.
- County Supervisors received \$1 million in funding per District and are requesting feedback about the Funding. A survey is being conducted and several supervisors are holding in-person/webinar events to gather information. Discussion of steps ACOA members can take to advocate for senior services to receive funding. Alicia will send to the Committee a proposed summary of effects of HR 1 as resource material.

- Center for Elders Independence opened 3 new PACE (Program of All Inclusive Care for the Elderly) centers in the East Bay (Livermore, El Sobrante, Oakland).

- Oscar Wei, Deputy Chief Economist with the California Association of Realtors gave a presentation on the housing market.

- SB 707 Legislation (to revise the Brown Act) has cleared the Suspense File and will be voted on before 9/12/2025. If it passes, it will be sent to the Governor's desk. He has until 10/30 to sign the bill. ACLU is still opposed. Supporters are working to get them to not oppose it.
 - California Senior Legislature session will be held at the end of October.

California Department of Aging (CDA) Access To Technology (ATT) Program

Administered by Contra Costa County's Area Agency on Aging



Access To Technology (ATT) Program

- Grant-based initiative by the California Department of Aging intended to reduce the "digital divide" for older adults and people with disabilities across the state.
- >> Purpose: to provide not just devices and connectivity, but also training and support so that participants can meaningfully use technology (rather than simply owning it).
- An opt-in county grant program, meaning that counties (via local agencies) choose to participate and receive funding to deliver ATT services in their jurisdictions
- >> Program Duration: 2022 September 30, 2024



Eligibility

- » Over 60 years of age OR over 18 years of age with a disability
- » Participants must be without a device or internet service
- » Participants must reside in Contra Costa County
- » Priority is given to individuals with greatest economic and social need

Overview of Program Goals

- » Expand access to technology
- » Reduce social isolation
- » Increase digital literacy
- » Strengthen community connections




Devices and Data Plans

Funding

- » Allocation: \$1.77 million
- » Spent: \$1.43 million
- » Remaining: \$0.34 million

Contra Costa County Public Health

AAA leveraged and utilized Public Health's infrastructure to render devices and training via existing APS case managers through established relationships with at risk clients.

Community Tech Network (CTN)

CTN (now Digital Lift) partnered with 15 CC CBOs by utilizing our well-established Provider Network to gain learner referrals, train Digital Lift Navigators, provide digital literacy training, produce tools/literacy guides, and conduct outreach to gain participants.

Proposed letter stating support for Assemblymember Wicks package of legislation supporting faster processing of housing requests.

To be addressed to all assembly members and state senators representing Contra Costa County.

The Contra Costa County Advisory Council on Aging (ACOA) advises the Board of Supervisors on matters related to the planning, development, and administration of programs for older adults and adults with disabilities. Please note that any comments, recommendations, opinions, or positions expressed by the ACOA or its members do not represent the official position of the County or its officers.

We are writing in support of the package of legislative bills being introduced in the State Senate and Assembly aimed at improving the efficiency of the review, approval, and construction of new housing. Known as the "Fast Track Housing Package," this collection of twenty-two complementary bills is designed to streamline the housing approval process without compromising environmental or safety standards.

Led by Assemblymember Wicks whose recognition that the current approval process is not working is the basis for this "Fast Track Housing Package". Through a bipartisan and bicameral approach, the strategy is taking meaningful steps to reform the system and accelerate the development of new housing projects. As outlined, the "Fast Track Housing Package" addresses five key bottlenecks in the approval process—application, CEQA compliance, entitlement, post-entitlement, and enforcement. These bills aim to eliminate inefficiencies at each of these stages, thereby reducing project timelines, lowering costs, and enabling faster housing development.

The lack of affordable housing **for the senior aging community and the disabled** is a critical issue affecting communities across California, particularly in Contra Costa County. The package of bills reflects a deep understanding of the housing development and approval process and it is a bold initiative to "reset" the system that is both far-reaching and well-supported on both sides of the aisle.

The Advisory Council on Aging appreciates Assemblymember Wicks for sponsoring and organizing this comprehensive legislative effort to increase the availability of new and affordable housing in our county and across the state and we are requesting your support in voting for this package of legislation.
