This renewal Statement of Work ("SOW") is between Contra Costa County, CA ("Customer") and CivicPlus, LLC, and shall be subject to the terms and conditions of the Master Services Agreement ("MSA"), as modified between the Parties on July 26, 2023, and applicable Solutions and Products terms found at: <a href="https://www.civicplus.help/hc/p/legal-stuff">www.civicplus.help/hc/p/legal-stuff</a>, (collectively, the "Terms and Conditions"). By signing this SOW, Customer expressly agrees to the Terms and Conditions throughout the Term of this SOW. The Terms and Conditions form the entire agreement between Customer and CivicPlus (collectively, referred to as the "Agreement"). The Parties agree the Agreement shall supersede and replace all prior agreements between the Parties with respect to the services provided by CivicPlus herein (the "Services").
- 2. This SOW shall remain in effect for an initial term from July 1, 2024 through June 30, 2025 (the "Initial Term"). In the event that neither party gives 60 days' notice to terminate prior to the end of the Initial Term, or any subsequent Renewal Term, this SOW shall automatically be renewed for an additional twelve month renewal term ("Renewal Term"). The Initial Term and all Renewal Terms are collectively referred to as the "Term".
- 3. The Annual Recurring Services Initial Term fees shall be invoiced July 1, 2024. Subsequent Annual Recurring Services shall be invoiced on July 1 of each year, and shall be subject to an annual 5% uplift. Customer will pay all invoices within 30 days of the date of such invoice.
