Supervisor John Gioia provided an update on several county initiatives affecting District 1. A \$1 million Community Impact Fund has been established for each supervisorial district to support community-based projects addressing health and economic disparities. The program allows grants of up to \$50,000 for nonprofit organizations or projects operating with a nonprofit fiscal sponsor. Applications for the program recently closed and are currently under review.

Supervisor Gioia also discussed a \$36 million funding program created from refinery-related fines and penalties associated with Chevron operations. These funds are intended to support public health improvements and economic transition efforts in communities most impacted by refinery emissions, including areas of West Contra Costa County.

The Board of Supervisors has also placed a proposed five-year, 5/8-cent sales tax measure on the June ballot. The measure is intended to offset potential federal reductions to Medicaid and other safety-net programs that could impact tens of thousands of Contra Costa County residents. Supervisor Gioia noted that reductions in healthcare coverage could place additional pressure on hospitals and emergency services if preventative and routine care become less accessible.

Updates were provided regarding Fire District operations and regional wildfire preparedness. The retirement of Fire Chief Lewis Broschard was announced, with the District beginning the process of identifying interim leadership. The District also reported progress on launching a new website and continuing community outreach efforts related to wildfire preparedness.

Michelle Rinehart discussed the increasing number of fires involving electric vehicles and lithium-ion batteries. To improve response capability, the District recently approved the purchase of two Cold Cut Cobra suppression systems, representing a \$200,000 investment funded through existing district resources. These specialized tools allow firefighters to penetrate sealed battery compartments and more effectively control high-energy battery fires that cannot be managed with conventional water streams.

Additional discussion highlighted the importance of defensible space and home hardening as critical

wildfire prevention strategies. The District has begun distributing informational door hangers to residents to provide guidance on vegetation management and wildfire risk reduction. The effort is intended to be educational and supportive rather than enforcement-based.
