10:10 Update – State Budget and Housing Impact – Cherise Khaund, Field Representative, Office of Assemblymember Rebecca Bauer-Kahan

Recent state legislation has helped spur housing development. For example, the Prohousing Designation Program awards priority points to cities/counties on state grants for adopting proactive policies that streamline approval, increase density, and reduce barriers to building housing. Moraga and Walnut Creek received designation.

Four developments in the 16th Assembly District were highlighted:

- Walnut Creek: Civic Crossings, Sierra Gardens Apartments
- Moraga: Moraga Park Street Senior Housing
- Lafayette: Lafayette Sunflower Hill

10:20 Presentation: Continuum of Care Annual Report/Point-in-Time – Jaime Jenett, Community Engagement Specialist, Contra Costa Health

Local Data Sources:

- Point-in-Time (PIT) Count: An annual one-night count during which volunteers canvas the community to identify the number of unhoused individuals.
- HMIS Data: The County's database system that collects person-level data over time, entered by providers and used to generate reports.

Annual Report:

- The purpose of the Annual Report is to provide a comprehensive summary of Continuum of Care (CoC) activities and outcomes. The report examines trends, analyzes data through an equity lens, highlights noteworthy initiatives, assesses system capacity, and identifies future objectives.
- There has been a steady increase in unique households and the number of people within those households accessing CoC services. Household enrollment across program model categories, 2024:
 - 67% household enrollment in crisis response (29% increase over 5 years).
 - 19% household enrollment in prevention and diversion for newly homeless individuals (111% increase over 5 years).
 - 14% household enrollment in permanent housing (51% increase over 5 years).
- Household trends – 5-year percent change:
 - 31% increase in adult-only households.
 - 79% increase in households with children.
- Older adults aged 55 and older represent 22% of the homeless population served by CoC in 2024. Five-year percent change: 18% increase in individuals aged 55–65 and a 69% increase in individuals aged 65 and older.
 - There is an inequitable overrepresentation of Black/African American and multiracial individuals among those experiencing homelessness.

2025 PIT:

- Most people experiencing homelessness in Contra Costa County lost their housing within the county.
- There has been a 34% increase in temporary and permanent housing beds since 2023.
- The 2025 PIT showed a 26% decrease in the number of people experiencing homelessness on a given night in Contra Costa County. The 2025 PIT count occurred on January 29, 2025.
- The 2026 Point-in-Time Count will take place on January 29, 2026. Volunteers are being recruited.
