The HLAC remained involved with the County General Plan update by assisting with action items COS-A10.1, 10.2, 10.3, and 10.4. within Chapter 7 of the new General Plan.

The HLAC continued to advocate that the County adopt a historic preservation ordinance.

The HLAC recommended to the Board of Supervisors the nomination of the Thiederman Residence at 205 Lake Drive in Kensington to the County Historic Resources Inventory (HRI).

The HLAC recommended to the Board of Supervisors that 1850 Alameda Diablo in Diablo and 205 Lake Drive in Kensington be approved for a Mills Act Contract.

The HLAC recommended to support the Contra Costa County Historical Society (CCCHS) with their request for an increased stipend from the County to cover inflation costs.

HLAC Chair, Carol Jensen, continued to represent the HLAC in being an active member of the Sacramento-San Joaquin Delta National Heritage Area Advisory Committee for the Delta Protection Commission.

The County will have added another resource to the County Historic Resources Inventory (HRI), 205 Lake Drive in Kensington, due to the HLAC's recommendation.

The HLAC attended the Transportation, Water and Infrastructure Committee (TWIC) meeting on February 24th to continue to support the development of a historic preservation ordinance for the County.

HLAC Chair, Carol Jensen, has collaborated with the County Historical Societies, and in doing so, located all resources listed in the HRI to assist the Department of Conservation and Development staff with action item COS-A10.1, updating the HRI.

HLAC committee member, Anthony Geisler, donated historical documents with respect to the founders of Save Mount Diablo to the CCCHS.
