In addition, the project will contain 1,488 s.f. of commercial space that will front on Willow Pass Road and Clearland Drive at the northwestern corner of the project.

1. Call to Order/Roll Call/Pledge of Allegiance

- 2. Public Comment A member of the public informed us that the CalTrans was currently taking input on the Bay Area bike plan. He said he would update us in March. A resident from Sycamore Ct. asked when they would complete the underground wiring on Willow Pass Road.
- **3. Approval of Minutes for February meeting** motion made by Member Lessley, second by Member Tremaine, motion carried 6/0/1 with Member Shah absent.
- **4. Approval of the Agenda** Chair Mason requested a change in the agenda to move up the Contra Costa County Fire District report due to a conflict in the schedule. Motion made to approve the agenda by Member Tremaine, second by Member Garcia-Lopez, motion carried 6/0/1

5. Agency Reports

- a. **Supervisor Scales-Preston Armando Carrasco** Armando reported that the Community Clean up would be on April 12, beginning at 8:00am and ending when all containers are full. A Resource for the community would be on April 26 at the Ambrose Community Center.
- b. Contra Costa County Fire District Michelle Rinehart Michelle reported that several communities were having community chipping days and encouraged us to do so. She shared that the LRA maps are available for public review and input.
- c. Contra Costa County Sheriff's Office- Lt. Rhanelle Daniels The Lt. reported calls

continue to be lower. In April they plan to have a basketball camp and the Bike Rodeo in May, which will be a little different this year. The Sheriff's has recently had lunch with students at Shore Acres Elementary.

- d. Contra Costa County Code Enforcement Joe Lasado and Bill Lovan- Joe reported that there were 32 new cases opened, 18 cases closed with 51 still outstanding. They had recently been in the Clearland area cited 8 people. New staff will start soon with one officer being designated in the Shore Acres area.
- e. **MOTCO** We had an update on the latest Coyote Shield meeting, it is still scheduled for June even though there has been some staff changes.
- f. **Golden State Water Tina Gonzalez –** Tina reported they continue with upgrades and they are doing an overhaul at Pullman and Fairview.
