What is IHSS?

- Helps aged, blind and long-term disabled people live in their homes with dignity rather than relying on institutions
- Recipients of IHSS can hire a provider of their choice to help them with personal care services
- IHSS can also provide wages to a provider for protective supervision





IHSS Eligibility Criteria



- 65 or older, blind or long-term disability
- Physically reside in the United States and be a California Resident
- Be approved for Medi-Cal services
- Live in their own home or other dwelling in which they choose to reside
 - acute care hospitals, skilled nursing facilities,
 and intermediate care facilities are not eligible
- Health Certification form completed by health care provider



What Does IHSS Cover?

Most activities of daily living, such as:

- Cooking
- Grocery Shopping
- Meal Prep and Clean Up
- Medical Appointment Accompaniment
- Spoon Feeding
- Help With Breathing Equipment
- Toileting or incontinence related needs
- Bathing and hygiene
- Dressing
- Medication Management
- Tooth, Nail and Hair care
- In some circumstances, protective supervision, one-time heavy cleaning or one-time yard hazard abatement





What does IHSS Not Cover?



- Moving Furniture
- Paying Bills
- Reading mail to you
- Caring for Pets
 (including service animals)
- Gardening
- Repair Services
- Social Outings
- Sitting to visit or watch TV


This number is staffed during business hours (Monday-Friday) and messages can be left after 5 p.m. or on weekends

Anyone can make a referral. All contacts are referrals until the county has contacted the individual or their AR to determine whether the individual is interested in applying.


Application will be sent to a Social Worker who will schedule a home visit.








State Changes that Impact IHSS



California FY25/26 Budget

- Signed by Governor Newsom on June 27, 2025
- Effective 7/1/25 Overdue CFCO
 Reassessment Penalties passed to Counties
- Effective 1/1/26 Re-instates asset limits of \$130,000 for an individual and \$65,000 for each additional individual for certain Medi-Cal enrollees. As Medi-Cal is a pre-requisite for IHSS, this could also impact IHSS recipients.



Federal Changes that Impact IHSS

House Resolution 1 (H.R. 1)

- Signed by President Trump of July 4, 2025
- Changes to Medi-Cal
 - Effective 1/1/27- Reinvestigation every 6 months, instead of 12 months
 - Effective 1/1/27- Work Requirements
 - Effective 1/1/27- Limits Retroactive coverage to 1 month for expansion enrollees and 2 months for other enrollees (instead of 90 days)
 - 10/1/26- Removes eligibility for 5 legal immigrant categories





Case Processing Timelines



The goal is for all Intakes and Reassessments to be processed timely.

- Intakes are considered timely if processed within 90 days of application
- Reassessments take place once a year.
- 80% timeliness for Overall Reassessments is required for State Compliance.
- 100% timeliness for CFCO Reassessments is required for Federal compliance to not receive fiscal penalty
