1. Roll Call and Introductions

No quorum declared.

2. Public Comment on Items Not on the Agenda

Public Comment: None

3. RECEIVE and APPROVE Record of Action for June 12, 2025

Ellen moved to approve; LaShanda seconded. Voted unanimously to approve.

4. UPDATE on RJOB Full Body and Subcommittee Progress

Ellen shared updates on the Statement of Support drafted by the subcommittee. Discussion followed regarding whether policy statements fall under RJOB's purview. Stephanie asked staff to provide bylaws and advisory handbook for clarity. Marya noted the importance of actionable follow-up items rather than symbolic gestures.

Stephanie shared that the CEF Ad Hoc Committee is meeting monthly to plan community gatherings (three in February and March).

The group discussed creating a work group focused on pretrial diversion to map existing efforts and identify data gaps. Ellen, LaShanda, and Cheryl volunteered to lead.

A second work group will review youth diversion eligibility criteria (Ellen, LaShanda, DA representative).

5. DISCUSS Sheriff Department's Presentations (Truth Act Forum and Quarterly Report)

Members discussed the racial disparities in immigration enforcement and data gaps in the Sheriff's reporting.

Ellen referenced other counties (San Mateo, Santa Clara) implementing stronger local protections.

Marya suggested inviting the Sheriff's representative to a future RJOB meeting. Staff clarified that ordinances cannot compel the Sheriff's Office to act; only BOS directives can apply.

Public Comment:

Jill Ray emphasized clarifying RJOB's role and avoiding conflation between ICE activities and the Sheriff's data report, which only includes booked criminal arrests.

6. Subcommittee Member Updates

No updates shared.

7. REVIEW and ASSIGN Action Items

- Staff will coordinate with Data Subcommittee Chair to form a joint work group reviewing the Sheriff's Report.
- Diversion Subcommittee Working Group (Pretrial Services): Ellen, LaShanda, and Cheryl to meet.
- Youth Diversion Criteria Group: Ellen (or designee), LaShanda, and DA representative (Stephanie to follow up).

World Café Prompt Development Guide for Subcommittees

Goal: Each subcommittee develop **3 connected prompts** that guide participants through **Reflection** → **Exploration** → **Action** and connect to the overarching Town Hall themes:

- What's missing in RJOB's work or from the perspective of the community?
- What do participants still want to know or understand?
- How does the community want RJOB to engage them?
- Concerns about racial disparities in the justice system.
- How does RJOB's work impact specific communities?
- Community engagement considerations across race, age, and geography.

Overarching Town Hall Themes:

- What's missing from RJOB's work or this presentation?
- What do participants still want to know?
- How does the community want RJOB to engage them?
- Concerns about racial disparities in criminal justice systems.
- How does RJOB's work impact specific communities?
- Community engagement considerations across race, age, and geography.

How Each Subcommittee Can Make Prompts Specific

- 1. Community Engagement Breakout:
 - o Focus on how RJOB can interact with the community.
 - Examples to think about: "What engagement methods work best in your neighborhood?" or "How should RJOB prioritize outreach to youth or

marginalized groups?"

2. Diversion Breakout::

- o Focus on gaps, barriers, or improvements in diversion programs.
- Examples: "What diversion options are missing in your area?" or "How can diversion better meet the needs of youth impacted by the justice system?"

3. Data Breakout:

- o Focus on data gaps, transparency, or utility.
- Examples: "What information is missing to understand justice outcomes?" or "How can data better reflect your community's experiences?"

Tips for Subcommittees:

- Ensure prompts **build on each other**: Reflection \rightarrow Insight \rightarrow Action.
- Keep language simple and accessible.
- Test whether each prompt encourages **multiple perspectives and rich discussion**, not just yes/no answers.

Commented [1]: When met with confrontation, or argument, direct the question towards them about what productive solutions can be.

World Café Prompt Development Template

Prompt #	Purpose	Guiding Questions to Consider	Draft Prompt
1 – Reflection / Observation	Invite participants to share experiences or perspectives	- What's missing in your community related to this focus area? - What issues or experiences matter most to you? - What questions or concerns might participants have?	
2 – Exploration / Insight	Encourage deeper thinking about causes, challenges, or priorities	- Why do these gaps exist? - What barriers or opportunities exist in your community? - How do factors like race, age, or geography influence this focus area?	
3 – Action / Visioning	Invite suggestions for solutions, engagement, or next steps	- How could RJOB better respond to community needs in this area? - What would effective action or engagement look like? - What are practical steps RJOB could take to make an impact?
