**4.** RECEIVE presentation on the San Francisco Estuary Institute's shallow groundwater mapping and Baylands resilience efforts in Contra Costa County and provide direction to staff as appropriate.

The Committee ACCEPTED the presentation and expressed appreciation for SFEI's work.

The Committee asked clarifying questions regarding groundwater monitoring data, seasonal fluctuations, and geology's influence on groundwater rise and also raised questions about potential water quality concern. Additionally, inquiring about the relationship between groundwater rise and contaminated shoreline sites (referencing the former Zeneca site in Richmond) and how remediation may be affected by sea level rise.

Staff noted the County is coordinating with Solano County and exploring potential grant funding for additional Delta-focused groundwater analysis, also emphasizing the County's role in providing input on draft mapping and connecting SFEI's work with local jurisdictions.

### **PUBLIC COMMENT:**

The public asked whether SFEI could include a map layer identifying known contaminated sites. Ellen noted existing datasets from DTSC and the Water Board and referenced UC Berkeley's past efforts. The public also expressed strong support for nature-based shoreline solutions, praised SFEI's work, and encouraged elevating public awareness of these efforts.

**5.** RECEIVE presentation on the Contra Costa Resilient Shoreline Coalition and provide direction to staff as appropriate.

The Committee ACCEPTED the presentation and expressed support for building the coalition as a collaborative, inclusive effort.

The Committee received a presentation from staff on the proposed Contra Costa Resilient Shoreline Coalition. Staff explained that the coalition will serve as an inclusive framework to support shoreline adaptation planning in compliance with BCDC's Regional Shoreline Adaptation Plan requirements. The coalition will include cities, special districts, private landowners, community-based organizations, and regional partners, with participation levels tailored to organizational capacity. Staff noted the County has secured \$1.5 million in State funding to support this effort and described how coalition building may be guided by operational landscape units (OLUs) to align with watershed and shoreline geography.

The Committee asked clarifying questions about jurisdictional participation, specifically whether non-shoreline jurisdictions such as Concord and Oakley would be included, and confirmed they may voluntarily participate. Questions were also raised about compatibility with Delta-specific planning efforts (e.g., Delta Adapts) and how shoreline data can be aligned to ensure consistency across jurisdictions. The Committee also inquired about prioritization of shoreline areas most vulnerable to sea level rise, with particular focus on unincorporated communities such as North Richmond, Rodeo, Crockett, and Bay Point.

Staff responded that the County is responsible for unincorporated shoreline areas under State law, and those areas are prioritized in the County's resilient shoreline plan. Richmond is pursuing its own plan, but coordination will continue to ensure alignment. Staff emphasized that while BCDC's jurisdiction does not require plans for all communities, the County intends to include non-mandated areas such as Bethel Island and Discovery Bay for broader resiliency planning. Staff also confirmed that special districts can be incorporated into the coalition and shoreline plan.

### **PUBLIC COMMENT:**

The public asked questions regarding the timeline for the County's shoreline plan, how coordination will occur across county lines to avoid conflicting outcomes, and how priorities will be determined to ensure the most vulnerable communities receive attention first. Members of the public expressed interest in seeing stronger prioritization of unincorporated shoreline areas such as North Richmond, and also offered to share proposals for nature-based shoreline projects to support the coalition's planning.

The Committee ACCEPTED the staff report.

The Committee received a report from staff on activities supporting the Contra Costa Resilient Shoreline Committee. Staff reported that the County's updated scope of work has been reviewed and approved by the Ocean Protection Council's program manager and is now awaiting State signatures to execute the grant agreement. In anticipation of final approval, staff has drafted a memorandum of understanding to allocate grant funds to participating cities for shoreline planning activities, which is currently under review by city planning staff and their respective councils.

Staff also reported on preparations for a Shoreline Leadership Academy, to be launched in partnership with BCDC in September. This effort will support coalition members, cities, and community partners in advancing shoreline resiliency planning. Staff emphasized the importance of coordination between the County, cities, and special districts to maximize efficiency and ensure consistency in resiliency planning across jurisdictions.

The Committee acknowledged staff efforts and highlighted the importance of

safeguarding scientific data, particularly given recent challenges to environmental funding and grants. Members stressed the need to preserve and protect data so that resiliency work remains supported and verifiable in the future.

### **Referral History:**

Staff from the San Francisco Bay Conservation and Development Commission (BCDC) presented to the Contra Costa Resilient Shoreline Committee throughout the development of the Regional Shoreline Adaptation Plan (RSAP), most recently by Dana Brechwald, BCDC Assistant Planning Director for Climate Adaptation, on September 9, 2024. The RSAP includes a region-wide vision, priorities for a resilient San Francisco Bay shoreline, and guidelines that local governments must follow when developing Subregional Shoreline Adaptation Plans. 



### **Referral History:**

Phoenix Armenta, San Francisco Bay Conservation and Development Commission Senior Manager for Climate Equity and Community Engagement provided a presentation on the Contra Costa County Shoreline Leadership Academy to the Contra Costa Resilient Shoreline Committee on June 13, 2024. The Contra Costa Shoreline Leadership Academy is an opportunity to build capacity in the communities along the County's shoreline by offering a six-month long training and planning process to participants focused on learning about the shoreline, climate change and sea level rise. The Contra Costa County Shoreline Leadership Academy curriculum is based on San Francisco Bay Conservation and Development Commission's One Bay Vision with the curriculum tailored to fit the local context.

### **Referral Update:**

Since the Contra Costa County Shoreline Leadership was first presented to the Contra Costa Resilient Shoreline Committee, The Watershed Project and Contra Costa Resource Conservation District have been brought onto the project team. The project team consists of staff from the Contra Costa County Department of Conservation and Development, San Francisco Bay Conservation and Development Commission, Delta Stewardship Council, The Watershed Project, Contra Costa Resource Conservation District, and Exploratorium.







### Contra Costa Resilient Shoreline Staff Report for Contra Costa Resilient Shoreline Committee September 8, 2025

Key activities since the Resilient Shoreline Committee's meeting on February 18, 2025, are listed below.

### **Senate Bill 1 Grant**

The \$1,499,285 grant awarded by the California Ocean Protection Council (OPC) through the <u>Senate Bill 1 Sea Level Rise Adaptation Planning Grant Program</u> (SB 1 Grant Program) will support the development of the Contra Costa Resilient Shoreline Plan (Plan).

- The SB 1 Grant was executed in May 2025. Staff have begun work on the grant, which will occur through June 2027.
- Seven shoreline cities have signed a Memorandum of Understanding with the County to facilitate collaboration with shoreline cities during the term of the grant.
- Request for Proposals (RFPs) for community engagement and technical subcontractors to
  assist with the development of the Plan were released in June 2025. Staff are in the process of
  contracting with the selected subcontractors and expect to have finalized agreements this fall.
- Staff submitted the first quarterly report to OPC in July 2025.

### **Contra Costa County Shoreline Leadership Academy**

- The project team began planning for the Contra Costa County Shoreline Leadership Academy (SLA) in summer 2025. The SLA will engage a cohort of residents from shoreline communities in a six-month process in which they will be trained by experts in sea level rise, shoreline adaptation, nature-based solutions, shoreline contamination remediation, and other topics through virtual and in-person experiences to be prepared to engage in policy, planning, and projects related to shoreline adaptation and the development of the Contra Costa Resilient Shoreline Plan. The program is a collaboration among the County, the San Francisco Bay Conservation and Development Commission, the Delta Stewardship Council, the Exploratorium, The Watershed Project, and the Contra Costa Resource Conservation District.
- Recruitment for the SLA will begin in September with applications due in October. The SLA is expected to begin in January 2026.

### **Contra Costa Resilient Shoreline Coalition**

- Staff continue to meet with other local and regional public agencies to coordinate sea level rise planning efforts and build the Contra Costa Resilient Shoreline Coalition to support the planning and development of the Contra Costa Resilient Shoreline Plan.
- Staff continue to participate in regional sea level rise planning to raise awareness of the County's adaptation and resilience planning efforts and to ensure the Plan is consistent with regional guidelines.
  - In August 2025, staff attended the Bay Point Community Resource Fair and Contra Costa Block Party to talk with residents about the County's shoreline resilience planning efforts and other sustainability initiatives.
  - o On July 15, 2025, staff presented at the East Bay Leadership Council's Water and Energy Task Force, providing an overview of the Resilient Shoreline Coalition and other County efforts to support collaboration related to shoreline resilience.
  - o On May 9, 2025, staff presented at the Bay Planning Coalition Spring Summit, giving an overview of regional shoreline adaptation efforts in Contra Costa County.

### **Other Grant Opportunities**

- National Coastal Resilience Fund 2025 Application Submitted. Staff submitted an
  application to the National Fish & Wildlife Foundation's (NFWF) 2025 National Coastal
  Resilience Fund on July 17, 2025, for just under \$750,000. The funds would supplement SB 1
  Grant Program funding in key areas to develop the Contra Costa Resilient Shoreline Plan. Staff
  expect to hear from NFWF about decisions and potential next steps in November.
- Staff continue to monitor state and federal grant opportunities and prepare to apply for funding to support the Contra Costa Resilient Shoreline Plan. The Plan will create focused adaptation strategies and implementation actions for the communities along Contra Costa County's shoreline.
