1. CALL TO ORDER/ROLL CALL

The meeting was called to order at 6:30 pm.

2. PUBLIC COMMENTS

A. Parking & Traffic Safety Concerns

A Pacheco resident addressed the Council regarding ongoing parking and traffic safety concerns near the intersection of Pacheco Boulevard and Carolos/North Buchanan. Concerns included vehicles reportedly associated with a nearby smoke shop parking too close to the corner, causing congestion and a near-collision incident.

Additional safety issues were noted at the crosswalk near two bus stops, reports of speeding vehicles, and reference to a prior fatality at the intersection.

The speaker requested installation of flashing pedestrian crossing lights and/or crosswalk safety flags.

The Supervisor's Office will contact Public Works regarding potential crosswalk safety improvements, including the feasibility of flashing beacons, installation of a pedestrian flag system, and applicable permit or encroachment requirements. It was suggested that the area be evaluated for potential grant funding opportunities.

A. California Highway Patrol

There was No Report from California Highway Patrol.

B. Sheriff's Department

No significant crime trends were reported. Deputies continue monitoring encampments along the 680 corridor and investigating electrical theft activity. Routine patrol presence continues throughout the Pacheco area.

C. Pacheco Town Council

Mr. Marsh reported that Town Council elections are being planned, with a tentative target date of April 27. He also provided an update on the Town Council's financial status, reporting account balances of \$8,540.00 in checking and \$1,005.00 in savings. The credit line balance is \$2,488.00 and is scheduled to be paid off on the 17th.

Mr. Marsh also shared several facility and maintenance updates for the Pacheco Community Center. The facility will be closed through Presidents Day weekend to allow

for flooring replacement in the men's restroom. Temporary LED lighting has been installed in the parking lot, and additional lighting has been installed in the corner handicap parking area. A full LED lighting upgrade for the parking lot is a future goal and may be pursued through potential grant funding. In addition, all three thermostats at the facility are being replaced due to compatibility issues.

Mr. Marsh also announced several upcoming community events planned for 2026. These include a Rummage Sale on March 28, an Easter Egg Hunt on April 4, a Rummage Sale on October 17, a Thanksgiving Meal Event on November 21, and Pictures with Santa on December 12. These events are part of the Town Council's ongoing efforts to provide community activities for Pacheco residents.

D. District 5 Supervisor Shanelle Scales-Preston's Office

Mr. Carrasco reported several upcoming meetings and community initiatives. A grant workshop will be held on March 11 at the Martinez Refining Company Club House, to provide information and guidance on available funding opportunities. In addition, the preliminary meeting for the Marathon Community Benefits Agreement (CBA) Panel is scheduled for February 12. The mandatory bidders' conference for the Marathon CBA Agreement will take place on March 19.

The District V Office also announced that a tentative date of November 7, 2026, has been set for the Pacheco Community Cleanup event. This annual event is intended to support neighborhood beautification and provide residents with an opportunity to dispose of unwanted items and debris.
