1. Roll Call and Introductions:

Board Members Present: Andy Cohan, Dr. Vin Mathur, Linda Vaughn, Roger Guidi, Robert Durr, Linda Kralik, Bruce Gekko, and Judy-Lynn Kiersey (alternate). Absent: None.

County Reps: Jeff Schultz (Blackhawk Police Chief), Carol Mascali (Supervisor Andersen's Office), Tyler Hahn (CHP Representative)

Residents and guests present: In-Person: Andrew Konieczny (HOA), Sam Snow (public), Allan Snow (resident) Online: None.

2. Public comment on any item under the jurisdiction of the Committee and not on this agenda (speakers may be limited to two minutes):

Sam and Allan Snow: very happy with how things are going in BH. Concerns about stop sign violations on Deer Park, Deer Meadow, Live Oak and the main entrance of the community. We know the department is trying, but are concerned.

Chief: Department often park the "decoy car" in the area, but generally people obey the traffic laws when they see the police cars.

Allan Snow: Pedestrians with dogs become a hazard on the roadway.

4. Chief's Report: November & December 2025:

November '25

A. 467 Calls for Service: 4 Reports, 1 Felonies, 2 Misdemeanor, 1 Arrest
Felonies:

- Unknown suspects committed identity theft and credit card fraud. Victim noticed fraudulent charges, and reported to financial institutions and police quickly. Case forwarded to Investigations Division.

Misdemeanors:

- Hit & Run accident occurred on the corner of Deer Meadow Dr. and Blackhawk Club Dr. Victim vehicle was unoccupied and parked when it was struck causing moderate damage. No note was left or police notification was made by the responsible party.

- DUI driver was arrested during a moving violation near the intersection of Blackhawk Rd and Blackhawk Plaza Circle.

B. There was 1 arrest in November 2025, listed above.

C. Incident of Interest – No incidents of interest

D. Volunteers in Policing: 21 hours served by four volunteers. All volunteers provided routine security checks and Vacation House Checks/extra patrol, as well as supporting the donation collections.

December '25

A. 536 Calls for Service: 6 Reports, 1 Felony, 1 Misdemeanor, 2 Arrests
Felony:

- Victim's bank noticed suspicious activity on the account. Victim confirmed the action was forgery/fraud and the electronic transaction was not completed. Possible suspect was identified and investigation was forwarded to Detective's division.

Misdemeanor:

A domestic disturbance that turned physical was reported at a residence. A female was arrested and booked at the Martinez Detention Facility.

B. Two arrests occurred December 2025. One listed above (misdemeanor) and the second was a warrant service as listed below.

C. Incident of Interest – 12/17/2025 Detectives from the Sheriff's Investigation Division served a warrant at a residence in the Hidden Oaks Community resulting in the arrest of an adult male.

D. Volunteers in Policing: 15 hours served by four volunteers. All volunteers provided routine security checks and Vacation House Checks/extra patrol.

E. Items of interest:

- Beginning January 1, 2026 Vehicle Code 22651.08 allows police to impound Class 3 E-Bikes when operated by someone under the age of 16. Helmet Law is in effect if under 18 years of age. Parents can now be cited for this violation.

- Beginning January 1, 2026 Vehicle Code 426.1 defines an "off-highway electric motorcycle" (OHM) which are strictly prohibited from operating on public streets or roadways. Consequences include citations or possible

impounding of vehicles. BH streets and roads are considered public for purposes of vehicle code enforcement (1985 County Resolution).

- Scooters are different but same helmet law requirements.

More to come on all these changes.

Coffee with the Chief may occur in February, Resident offered to sponsor the event, but for definitely will resume in March 18, 2026 – weather permitting.

5. CHP Report: November & December 2025:
Officer Hahn reported that business is as usual. Weather makes things more difficult with 400 crashes (on local highways) a couple solo crashes on BH Road near Saddleback. One on Deer Trail. A lot of DUI arrests. The closing of Draegers does not change coverage.
6. Homeowners Association Report: None
7. Blackhawk Country Club Report: None
8. Old Business:
 1. Update on P2A community outreach: On January 21st, Chief Schultz will be presenting to the BH Women at their lunch meeting. The outreach from the P2A is to educate about what Police Services are doing. Many may not know that officers are not staffed 24 hours a day. Educate and inform. Two Board members will attend with the Chief and one of his officers.
9. New Business:
 - A. Update budget projections through '32/'33 – Chief and Andy Cohan will reconcile and report later. We will dip into reserves for approximately \$60,000 this year, and another \$100,000 in 2026/27. Reserves would be expended in 2028/29. Concerns about Blackhawk Plaza and how a foreclosure might impact the tax revenue for the P2A Services. Chief and Andy Cohan to conduct more research to obtain details to report next month.
 - B. Update on Brown Act from County
 - When Committee Members are approved to participate online, all votes require a role call.
 - Public attendees are not required to provide their names.
 - If a Board Member chooses to apply for a “reasonable accommodation” to participate remotely for the meeting, they will need to submit the request to the County at least one week prior to the first meeting for which the remote attendance is being requested.
 - If more than two board members are in communication, it is considered a meeting and covered by the Brown Act. This includes email correspondence.
 - C. Speed Bump approval - Speed Bumps are under the Blackhawk HOA's purview. Recommendation to have all the neighbors in agreement and take the request to the HOA.
