10:10 Health, Housing & Homeless (H3) Point-in-Time and Annual Report - Jaime Jennett, Community Engagement Specialist, Contra Costa Health Services. Provided an overview of the presentation.

2023 Continuum of Care (CoC) Annual Report data showed that 14,002 households utilized services in 2023, a 28% increase since 2019.

Main categories of services were Prevention & Diversion, Crisis Response, Permanent Housing. Older adults lowest utilizes prevention and diversion services and higher utilizes crisis response and permanent housing services.

2024 Homeless Point in Time (PIT). Date for next canvass for counting the homeless is January 30. The count for 2024 identified 2,843 people experiencing homelessness.

CoC has three access points: 211, CORE, and Care centers.

Vi-Spat Assessment Tool used for assessing vulnerabilities to identify and prioritize housing services for most at-risk individuals.

Home Court is for infractions only (low level)
