1. Roll Call

Chair Moore called the meeting to order at 5:06pm. 15 voting MXCAB members total were present, with 14 at the Martinez location and one participating remotely. In addition, two non-voting alternate members attended in Martinez. There were approximately 76 total virtual participants.

Public comment was received from one member of the public.

Chair Moore reviewed the process and timeline for the MXCAB to create and submit Measure X general funding priority recommendations to the Board of Supervisors, considering community outreach approaches, and past MXCAB funding recommendations and processes. Public input on emerging and current unmet community needs was invited and received by 20 members of the public. Most of the comments were supportive of funding related to African American Health and Wellness; and children's services, including mental health, tutoring, child care, parent engagement, and transitional age youth. Debbie Toth motioned to have a special session of the MXCAB before the next meeting on 9/20/23 to solicit more public feedback; seconded by Kathy Chiverton, and approved 12-0.
