Mr. March reported a balance of \$7,018 in checking, \$1,007 in savings and \$2,408 in a business line of credit. He reported on the Christmas event which he felt was very successful. There was a vandalism incident in which repairs were needed. They will continue to provide food distribution and tax aid services during the tax season. Mr. Marsh stated there were safety concerns regarding parking lot lighting and are currently working on those issues.

D. District 5 Supervisor Shanelle Scales-Preston's Office

Armando Carrasco announced that MAC Alternate Rittner has resigned. He stated that he is currently working on filling that position. He also reported on community outreach efforts and continued ongoing county coordination. Mr. Carrasco stated there would be a presentation from the Contra Costa Fire on an update regarding Fire Station #9 in the near future.
