Dr. Melinda Mclain gave a presentation around the history of the Good Table, current offerings, and history of the location.

The Council received an update regarding the remediation of a property owned by the Assemblies of God church along Appian Way. Representatives shared that toxic chemicals left behind by a previous tenant required the relocation of the church's school operations and prompted ongoing environmental cleanup efforts. Funding support has been partially secured through grant opportunities, though additional resources are still needed to complete remediation activities.

Discussion also focused on the long-term vision for the property, including the possibility of selling the site to a low-income housing developer. Community members emphasized the importance of maintaining mixed-use zoning opportunities along the Appian Way corridor, including the potential for ground-floor retail and community-serving uses. It was also noted that the church parking lot continues to support community activities, including the local farmers market.

Councilmembers discussed the importance of continuing coordination through the County's Envision Contra Costa 2040 planning process to help preserve long-term community development opportunities within the corridor.

Public comment on any item under the jurisdiction of the Committee and not on this agenda (speakers may be limited to two minutes).

The Council discussed community emergency preparedness efforts, including a proposal to identify a permanent location for an eight-by-thirty-foot storage container intended to support emergency response operations and incident command activities during disasters.

Community members and Councilmembers discussed several potential locations for the container, including publicly accessible sites near community facilities or fire response infrastructure. Participants emphasized the importance of selecting a secure and accessible location that would not be vulnerable to wildfire or other high-risk hazards.

Additional discussion highlighted ongoing Firewise activities, future emergency preparedness trainings, and opportunities to host ham radio and certification classes at community locations in the area. Councilmembers requested that a future presentation be scheduled to provide additional details regarding the proposed container and its intended emergency response functions.

Community members raised concerns regarding a recently announced increase in sewer service charges and requested additional information regarding the proposed rate adjustments.

Residents discussed ongoing infrastructure improvements occurring throughout several neighborhoods and expressed interest in learning more about the long-term maintenance and capital improvement needs

driving the proposed increases.

The Council discussed the upcoming public hearing related to the rate increase and encouraged interested residents to participate in order to better understand the proposed changes and provide public feedback. A request was also made for County wastewater representatives to attend a future Council meeting to provide additional information and answer community questions.

Announcements were shared regarding several upcoming community events. An Earth Day cleanup event is scheduled to take place on April 25, 2026, at the El Sobrante Library.

The Council also received information regarding an upcoming interfaith peace event at Easter Hill United Methodist Church featuring discussions focused on peacebuilding and community dialogue. The event will include participation from faith leaders representing multiple perspectives and backgrounds.

Additional comments highlighted ongoing community efforts to address discrimination and promote inclusion through education and public engagement opportunities.

Councilmembers shared brief updates regarding upcoming community meetings, outreach opportunities, and future presentations. Community members were encouraged to continue participating in local meetings and public engagement efforts.
