The Committee interviewed Igor Skaredoff, Renee Fernandez-Lipp, and Derene Allen. Applicant Lorena Castillo was not present. Igor Skaredoff corrected erroneous information in his application. At the conclusion of the interviews, the Committee decided to recommend reappointment of the three incumbents: Igor Skaredoff, Renee Fernandez-Lipp, and Lorena Castillo to the Board of Directors. The Committee encouraged Derene Allen to seek an Associate Director role with the District in order to gain more familiarity with the District and the responsibilities of its board of directors.

5. RECEIVE and CONSIDER approving the proposed Artificial Intelligence Policy or directing modifications to the policy for final recommendation to the Board of Supervisors. (Marc Shorr and Nathan Wiebe, Department of Information Technology)

PRESENTATION: Artificial Intelligence Policy

Chief Information Officer Marc Shorr outlined the draft Artificial Intelligence (AI) policy and emphasized three goals: to partner with and support responsible use of AI, to protect data, and accommodate exceptions to generative AI uses for limited business cases. Marc explained that AI is already in use in County government and discussed what is occurring industry-wide. Key to the policy will be employee education and training of the risks and benefits of AI, particularly in business cases involving personal identification information, personal health data, and other similarly sensitive data. DoIT's main strategy to reduce risk is to encourage use of AI tools made especially for government agencies, such as Microsoft Copilot for government agencies. He also stressed the responsibility for all County employees to verify and validate the output of AI applications.

Cyber Security Chief Rex Fujikawa discussed the security standards prescribed in the draft AI policy, which were developed collaboratively with Risk Management and County Counsel. An important element of the policy is a contractual standard for vendor security to ensure that the County is meeting any regulatory and legal compliance and that County departments are selecting and utilizing AI tools appropriate to each business case. Lastly, Rex discussed a plan for staff training and education, similar to the plan contained in the recent Cyber Security Policy.

In response to Chair Burgis's question about blocking risky applications on County devices, Rex explained that the County has the capability to block any application within the County's firewall and device management software.

Asst. CIO Nathan Wiebe summarized by saying that DoIT's goal is to be a good partner to departments, to provide guide rails and education on the use of AI, and to coach and advise those departments needing an exception to the AI tooling that DoIT will be providing at the enterprise level.

Vice Chair Andersen agreed that it will be important to provide department's AI tools that are trustworthy for government, but acknowledged that the draft policy is very

simplistic and likely has much more detail behind it in terms of its actual administration. She was supportive of the draft policy.

Chair Burgis expressed concern about employees not necessarily recognizing AI tools, since they are often embedded in everyday applications, e.g., spell check, Siri, Chat bots, etc.

John Dante commented that it costs tens and hundreds of millions of dollars to teach an AI model and asked what data would be used to teach a model? He cautioned the County to use caution going forward.

The Committee directed DoIT to bring the draft AI Policy to the Board in November as a discussion item.

Purchasing Services Manager Cindy Shehorn presented the staff report and recommendations. She reviewed the history of the County's Small Business Enterprise (SBE), Outreach, eOutreach, and Local Bid Preference programs and explained that staff's recommendations attempt to reconcile these separate programs to provide clear guidance for County departments. She noted that the County's new Purchasing Policy incorporates outreach protocols and effectively supersedes and replaces the County's old Outreach and eOutreach programs, which are recommended for abolishment. What would remain is an updated Small Business Enterprise Program and the Local Bid Preference Program, each which can stand independent of the larger County Purchasing Policy.

Cindy also explained that the Purchasing Division is currently reviewing the County's Procurement Card policy to re-evaluate the list of authorized transactions and will bring forth recommendations at a later date.

Tatiana Moger of DoIT demonstrated the County's new BizFinder web application, a mapping tool that can used to search businesses registered in the County's Purchasing Portal based on certain characteristics, such as local, small, minority or women owned, within a specified radius, by type of commodity or service offered, etc. The tool was designed specifically to support County departments to meet SBE goals but can be used for other purposes.

Vice Chair Andersen asked how we were spreading the word about Purchasing Portal Registration, to which staff replied that letters could be included in business license applications. Carrie Ricci reported that Purchasing has worked with the Office of Communication and Media to produce videos and brochures in multiple languages to

raise awareness, provide instruction, and facilitate online registration.

Chair Burgis asked staff to brainstorm if enough is being done and what else could be done to increase awareness of County business opportunities and portal registration.

Vice Chair Andersen was supportive of the amended policies and providing consistent messaging to departments in one place.

No one else requested to comment on the item.

The Committee approved staff's recommendations.

Animal Services Director Ben Winkleblack presented the annual report. He summarized the history of the Animal Benefit Fund and the service areas in which funds are currently dedicated: medical assistance, spay/neuter and wellness, and shelter intervention. He shared annual data, individual stories and photos of animals and families that benefited from services provided with this special funding, and expressed gratitude for the ability to provide this progressive but structured programming.

He reviewed his future goals to target specific communities where greater needs have been identified, to increase funding for shelter intervention and expand the number of service partners. He confirmed that the Animal Benefit Fund is a government fund, not a nonprofit corporation and, while he believes that donations to it are tax deductible, he cannot offer tax advice and donors should consult a tax accountant to verify.

Lisa Kirk commented on the need for adequate funding for Trap/Neuter/Return (TNR) for community cats and had many questions about fund allocation. The Committee directed Ms. Kirk to Animal Services administration for more information.

The Committee accepted the annual report and directed that it be forward to the Board of Supervisors on a future Consent calendar.

Referral History:

The Hazardous Materials Commission was established in 1986 to advise the Board, County staff and the mayor's council members, and staffs of the cities within the county on issues related to the development, approval, and administration of the County Hazardous Waste Management Plan. Specifically, the Board charged the Commission with drafting a Hazardous Materials Storage and Transportation Plan and Ordinance, coordinating the implementation of the Hazardous Materials Release Response Plan and inventory program, and analyzing and developing recommendations regarding hazardous materials issues with consideration to broad public input, and reporting back to the Board on referrals to the Commission.

The Hazardous Materials Commission includes 14 members, each with an appointed alternate, as follows: Three (3) City Representatives, Three (3) Business seats, Two (2) Environmental Organization Representatives, One (1) League of Women Voters, Two (2) Labor Representatives, One (1) Environmental Engineering Firm Representative (located in Contra Costa County), One (1) General Public Representative, and One (1) Environmental Justice Representative. Terms of office are four years. The Internal Operations Committee reviews Commission nominations for appointment to all but the City and League of Women Voters seats, and makes recommendations to the Board of Supervisors.

Referral Update:

Environmental Organization Seats. The terms of the Environmental Organization Seat #1 and the Environmental Organization Seat #1 Alternate will expire on December 31, 2024. The bylaws of the Commission provide that two (2) representatives of environmental organizations, with all applicants to any of the two "Environmental Organization" seats are to be nominated by an environmental organization, but that no particular environmental organization will have an exclusive right to nominate an individual to any one of the two aforesaid seats or their alternates and, therefore, which environmental organizations are represented on the Hazardous Materials Commission rests with the Internal Operations Committee and ultimately the Board of Supervisors.

The Hazardous Materials Commission recruited for the Environmental Organization seat #1 and its Alternate

and received two qualifying applications (attached). After conducting interviews, the Commission unanimously voted to recommend Jamin Pursell for the Environmental Organization seat and Louis Flores for the Environmental Organization Alternate seat. The terms for these seats will expire on December 31, 2028.

Business Seats. The terms of Business Seat #3 and Business Seat #3 Alternate will expire on December 31, 2024. The bylaws of the Commission provide that Business Seat #3 and its alternate be nominated by the Contra Costa Taxpayers Association, screened by the Internal Operations Committee and appointed by the Board of Supervisors. The Contra Costa Taxpayers Association has nominated Andrew Graham for Business Seat #3 and Frank Qin for Business Seat #3 Alternate (attached). The terms for these seats expire on December 31, 2028.

Referral History:

On December 12, 2000, the Board of Supervisors approved a policy on the process for recruiting applicants for selected advisory bodies of the Board. This policy requires open recruitment for all vacancies to At Large seats appointed by the Board. The Board also directed that the IOC personally conduct interviews of applicants for At Large seats on several boards, committees, and commissions including the Contra Costa County Fire Protection District Advisory Commission.

The Contra Costa County Fire Protection District Advisory Fire Commission includes ten (10) seats that are appointed by the Contra Costa County Board of Supervisors: Five (5) Supervisors District seats, Two (2) At-Large seats, and Three (3) Alternate seats that are filled in the same manner as At Large seats. The Advisory Fire Commission's purpose is to confirm cost of abatement reports; conduct weed abatement appeal hearings; approve surplus equipment declarations; and advise the Fire Chief on District service matters. The Commission also serves as a liaison between the Board of Directors and the community and may be asked to perform other duties by the Board of Directors.

Referral Update:

The At Large Alternate #2 seat on the Advisory Fire Commission was vacated in September 2024 due to the resignation of Madhan Guna.

Staff opened a recruitment on September 27, 2024 and received one application, attached, from Mario DiPrisco (Lafayette). Staff also reached out to Raed AlZaher (El Cerrito), who applied last May, but staff received no response.

Mr. DiPrisco was invited to attend today's meeting in case the Committee wishes to interview him. A current Commission roster is attached.

Note that the At Large Alternate #3 seat is also vacant. It is recommended that this seat continue to be held vacant pending resolution of the proposed annexation of the Rodeo-Hercules Fire Protection District in 2025.

Fish and Wildlife Committee "FWC" Membership Structure & Appointment Process

There are 10 members on the FWC: one from each Supervisor's District, four At-large members, and one At-large Alternate. A current roster indicating the Supervisorial District or At-large seat that the member represents, their appointment and term expiration dates, as well as their city of residence or employment is attached. The terms expire on a rotational basis, so as to have internal continuity on the FWC. The five district seats are nominated by the corresponding Supervisor. When one of these membership positions is available, the public may submit an application directly to the Supervisor's office. For the four At-large positions and one At-large Alternate position, the FWC publicizes the vacancies to recruit candidates. The Internal Operations Committee considers applications from all interested individuals, conducts interviews and recommends appointments to the Board.

Referral History:

Fish and Wildlife Propagation Fund

The Fish and Wildlife Propagation Fund (Fund) was established in accordance with the California Fish and Game Code (Code) 13100 as a repository for fines collected for certain violations of the Code and other regulations related to fish and game. The most common fines are small (\$25-\$150) and are processed through the four Superior Courts in Contra Costa County. A portion of the fines are deposited into the Fund. The fines typically stem from hunting or fishing violations (e.g. not possessing a valid license) and illegal dumping. Occasionally portions of larger fines that result from violations, including failure to obtain appropriate permits for activities such as streambed alteration, illegal take of a special status species, and pollution of waters are deposited into the Fund. In 2022, due to the settlement of The People of the State of California vs. LP, SFPP, regarding a Kinder Morgan ruptured oil pipeline that leaked a large amount of gasoline into a drainage canal that occurred in November 2020, a deposit of \$497,500 was made into the Fund. As of November 7, 2024, the Fund had an available balance of \$543,039.69.

FWC Grant Program

The Board has charged the FWC with coordinating a process by which fine money could be appropriately "expended for the protection, conservation, propagation, and preservation of fish and wildlife" [Fish and Game Code 13100]. Since 1996, the FWC has implemented a structured process for reviewing funding requests. The FWC developed a grant application packet (attached), which includes a cover letter to explain the grant process and funding priorities, an application to solicit relevant information about the project, and a copy of the expenditure criteria established by California law for the Fish and Wildlife Propagation Fund.

Public Outreach to Advertise the Grant Program

On May 23, 2024, the application packet was sent to the Fish and Wildlife Committee mailing list, the Contra Costa Watershed Forum mailing list, all Contra Costa County school districts, Contra Costa College, Diablo Valley College, Los Medanos College, UC Berkeley, Cal State University - East Bay, University of California Agriculture and Natural Resources, and St. Mary's College. The CCC Office of Communications and Media

distributed a press release to local and regional media outlets regarding the availability of the grant application packet. CCTV publicized it on the CountyNet Bulletin Board which reaches 400,000+ homes in the County. Supervisors also included the announcement in their email newsletters. It was posted as a newsflash on the Department of Conservation and Development's website and displayed on its social media accounts: Facebook, Instagram and X. It was also made available on the Committee's website and to anyone who requested a copy.

Referral Update:

FWC Review Process for 2025 Grant Awards

12 applications requesting a total of \$112,065.26 were reviewed.

The Fish and Wildlife Committee members considered the funding of the applications at their September and October meetings. Several applicants attended the meetings to make themselves available to answer questions regarding their applications.

The Contra Costa County Fish and Wildlife Committee (FWC) completed its review of the 2025 grant requests for funding from the Fish and Wildlife Propagation Fund (Fund) and is forwarding its grant award recommendations to the Internal Operations Committee (IO). The FWC reviewed 12 grant applications and recommends that all of them receive full or partial funding. The FWC is requesting that the IO Committee consider these recommendations and make their own recommendation for consideration by the full Board of Supervisors (Board). This memo provides background on the grant program, explains the review process performed by the FWC and documents the FWC's recommendations on grant funding.

Recommendation(s)/Next Step(s):

At its October 16, 2024 meeting, the FWC recommended full or partial funding for all of the proposed projects. Projects recommended for funding total \$80,910.50 and are geographically located across the County. More details are provided on the attached grant recommendations chart, which provides information on all of the applications. The specific FWC recommendations and vote are listed on Pages 2 through 4 of this memo. Members in attendance and voting on these items were: Nicole Balbas (Atlarge), Susan Heckly (District II), Roni Gehlke (At-large), Kathleen Jennings (At-large), Brett Morris (District IV), Daniel Pellegrini (District V), and Jamin Pursell (District I).

The following recommendations are for full funding of the project as proposed unless noted otherwise.

FWC Recommendations:

- 1. Allocate \$6,444.00 to Golden Gate Bird Alliance for their "San Francisco Bay Osprey Camera" project. This project will support a valuable educational resource that fosters public understanding of osprey conservation and environmental stewardship by providing continued access to live streaming and real-time footage, which educators use to illustrate osprey behavior and highlight the success of conservation efforts in the Bay Area. Funds will be used to cover the monthly costs of webcam streaming, hosting services, and the website, including the live chat feature for one year.
- 2. Allocate \$3,745.00 to Golden Gate Bird Alliance for their "Bringing Back the Natives Events" project. This project will support educational events that inspire Contra Costa residents to transform their

gardens into habitats for native wildlife, fostering ecological diversity and contributing to the protection of declining species. Partial funding is recommended and may only be used for facility rental, Zoom fees, t-shirts, and metal holders for keystone species signs, with the 2024 Fall Conference facility rental to be reimbursed retroactively.

- 3. Allocate \$7,200.00 to Things that Creep for their "Pocket Guide to the 30 Native Reptile Species in the San Francisco Bay Area" project. This project will provide Contra Costa County students, schools, and libraries with a valuable educational resource that enhances understanding of local reptiles, including threatened or endangered species, while promoting safe and respectful human-wildlife interactions and supporting conservation efforts. Partial funding is recommended and may only be used for printing 3,000 4-panel laminated pocket field guides.
 - ** The FWC recommends approval of the applicant's request for an exception for non-profit organizations that can demonstrate financial hardship that would allow for a partial disbursement of funds (up to 1/2 of the grant award) after the grant is awarded.
- 4. Allocate \$7,030.00 to the John Muir Chapter of Trout Unlimited for their "Wildcat Creek Water Quality and Fish Habitat Monitoring Study" project. This project will enable JMTU to gather essential data on Wildcat Creek's hydrology and water quality, improving understanding of spawning and rearing conditions for anadromous fish and guiding interventions to enhance fish passage and habitat quality, while also training and involving citizen monitors in efforts to improve water quality in Contra Costa County, ultimately providing suitable habitat for coldwater fish populations. Funds will be used to purchase YSI Pro 20 DO/T Sensors, Cap and Membrane Kits, Oakton PCTS Testr30, replacement for Onset Hobo Unit (U26-001), Onset DO Sensor Caps (U26-RDOB-1), Onset DO Sensor Batteries, and waders.
 - **The FWC recommends approval of the applicant's request for an exception for non-profit organizations that can demonstrate financial hardship that would allow for a partial disbursement of funds (up to ½ of the grant award) after the grant is awarded.
- 5. Allocate \$1,030.00 to Worth a Dam for their "Beaver dams build neighborhoods: Playing with a full deck" project. This project will support a fun, hands-on activity at the Beaver Festival where children can explore the ecosystems of beaver ponds, collect trading cards, and discover artwork beneath their feet as they walk around, deepening their understanding of how beaver ponds shape local ecosystems while fostering a personal connection to the creatures and habitats of their watershed. Funds will be used to purchase trading cards, credit card sleeves, exhibit location maps, trading card flags, chalk pastels, and printing of signs and post tests.
- 6. Allocate \$926.60 to Lindsay Wildlife Experience for their "Mammal pen construction for wildlife rehabilitation" project. Due to the Committee's preference for supporting material costs over labordriven expenses, they recommend partial funding for the purchase of a supply shed only, which will enhance operational efficiency and ensure that rehabilitation supplies are readily available.
- 7. Allocate \$19,449.66 to International Bird Rescue for their "Ethically and Effectively Resolving Human/Wildlife Interaction Issues in Contra Costa County Through Temporary Emergency Treatment and Care of Injured and Orphaned Wildlife" project. This project will support the replacement of outdated equipment and materials, ensuring effective rehabilitation for injured and orphaned aquatic birds from Contra Costa County, and enhance biodiversity by facilitating their return to natural habitats. Funds will be used to purchase a Tuff shed, pet dryers, pool filter sand 50 lb. bags, and above ground pool pumps.

- 8. Allocate \$10,690.00 to The Watershed Project for their "Contra Costa Water Quality Monitoring and Water Quality Apprenticeship Training Program" project. TWP's Water Quality Monitoring Program trains, educates, and engages community members and scientists in activities that analyze and discuss the County's water quality in order to enhance water quality to support healthy habitats for fish and wildlife. Additionally, TWP offers a youth education program through the Water Quality Apprenticeship Training Program. Partial funding is recommended for purchasing equipment replacement parts, calibration standards, existing equipment repair fees, supplemental safety items to protect the monitoring crews, sending Benthic Macroinvertebrate and bioswale stormwater, soil, wood piece samples to a scientific lab for processing, and educational materials; and may not be used for the Water Quality Monitoring Annual event venue fee, catering, and outreach materials as listed in TWP's grant application.
- 9. Allocate \$582.00 to SPAWNERS for their "Water Quality Monitoring Equipment for Students" project. The project will provide materials to teach students in grades 4-12 about watershed ecology, the effects of human activity on watersheds, and the scientific principles of fish and wildlife conservation. Funds will be used to purchase water monitoring kits, refill tablets for nitrate, phosphate, DO, BOD, pH, and coliform, a plastic tote bin, and a ream of paper.
- 10. 10) Allocate \$1,463.00 to Marine Science Institute for their "2025 Delta Discovery Voyage Program" project. The project provides public education that is aligned with CA Common Core and NGSS for public schools, focusing on scientific principles of fish and wildlife conservation by using supervised formal instruction conducted with a planned curriculum and aids to education. Partial funding is recommended to purchase expendable supplies: buckets, fish keys, posters, nets, vials and slides as listed in their grant application; and may not be used for vessel fuel and harbor fees. The Committee recommends that if the final approval of this grant takes place in 2025, MSI may be reimbursed retroactively to allow them to purchase supplies in December, before the voyages begin in January.
- 11. Allocate \$5,680.24 to Save Mount Diablo for their "Expanding the Kestrel Population on Mount Diablo" project. This project will provide equipment to monitor and assist kestrel population expansion on Mount Diablo. Partial funding is recommended for research intern payments, WIFI bluetooth trail cameras, lithium batteries, SD cards, and materials for nest boxes; and may not be used for land stewardship manager payment.
- 12. Allocate \$16,670.00 to Lindsay Wildlife Experience for their "The Bear Den" project. The exhibit will support local and global conservation efforts by providing an engaging, interactive space that educates visitors about Grizzly, Black, and Polar Bears, and will focus on the importance of dwindling habitats, regional extinction, and the impact of climate change. Partial funding is recommended for all exhibit signage, graphics, exhibit titles, and 3D interactives and displays; and may not be used for graphic design related to signage, graphics, and exhibit layout as outlined in the grant application.
- 13. Further, the FWC also recommended that within a year of grant funding approval, or within one month of project completion, whichever comes sooner, recipients must submit a final project report which includes invoices and receipts documenting how funds were spent and the results of the project. Details will be outlined in the grant award packet provided to all successful applicants.

The Contra Costa County Fish and Wildlife Committee is pleased to announce that completed funding applications are now being accepted for consideration for the Contra Costa County Fish and Wildlife Propagation Fund (Fund). All application materials and guidelines are attached. Proposals must be received by 5:00 p.m. on Thursday, August 1, 2024 (a postmark of August 1, 2024, does not satisfy the submission deadline). Proposals may be emailed or mailed. Any applications that are received after the due date or without a signature will not be considered. Staff will acknowledge receipt of each grant application. If you do not receive a confirmation of receipt contact Maureen Parkes at 925-655-2909 prior to the deadline. The recommendations of the Fish and Wildlife Committee will be forwarded to the Contra Costa County Board of Supervisors, which maintains final decision-making authority for expenditures from the Fund.

The Contra Costa County Fish and Wildlife Propagation Fund is entirely supported by fine revenues resulting from violations of the Fish and Game Code and Title 14 of the California Code of Regulations in Contra Costa County (County). Projects awarded from the Fund must benefit the fish and wildlife resources of the County and must meet the requirements of Section 13103 of the Fish and Game Code (attached). If your project is eligible under Section 13103 (d), (h), (i), or (m) please send a copy of your draft proposal to Maureen Parkes at maureen parkes@dcd.cccounty.us by June 28, 2024. Staff will coordinate with the California Department of Fish and Wildlife to confirm the project's eligibility to receive funds. See Instructions for more details. All applications that satisfy the requirements listed in the funding application instructions will be considered.

The Fish and Wildlife Committee strongly encourages applications related to:

- improving habitat
- scientific research
- public education
- threatened and endangered species
- resolving human/wildlife interaction issues

In addition to the above areas of interest, the Fish and Wildlife Committee wishes to fund one or more projects that increase collaboration with law enforcement agencies and community cultural organizations on enforcement issues and education focusing on communities that may be unaware of local fish and game laws. Projects that provide multilingual signage and educational materials are encouraged.

The Fish and Wildlife Committee considers grant awards for prospective expenditures from non-profit organizations, schools, and government agencies. The Committee generally does not recommend funding for operating costs and overhead, such as staff salaries, benefits, or utilities. The Committee generally gives preference to funding material expenses (e.g. purchase of equipment and materials). Organizations, schools, and government agencies that have received previous Fish and Wildlife Propagation Fund grants should have a positive track record of completing projects and submitting final reports in an efficient, timely and clear manner.

The Committee expects to recommend awards to several applicants. However, it is possible that a particularly excellent proposal will be recommended to receive a large portion of the total available funds. During the 2024 grant cycle a total of \$74,522 was awarded to 11 projects. The awards ranged from \$910 to \$16,807. Available funds vary from year to year and the Fish and Wildlife Committee cannot commit to multi-year or recurring funding. The Board of Supervisors will make the final decision on the grant awards and successful applicants may anticipate receiving notification by January 2025. Project expenditures eligible for reimbursement must be made subsequent to Board of Supervisors approval of grant funding.

The grant award funds will be disbursed on a cost reimbursement basis.* (See below for exceptions.) Within a year of grant funding approval, or within one month of project completion, whichever comes sooner, recipients must submit a final project report which includes invoices and receipts documenting how funds were spent and the results of the project. Grant awardees may request a budget modification to address any proposed changes to the project costs. This request must be made in writing prior to incurring the unapproved expenses. Unapproved expenses will not be reimbursable. Fish and Wildlife Propagation fund grants will be disbursed after receipt and approval of the final project report. Details will be outlined in the grant award letter that is sent to all successful applicants.

*Exception For Non-Profit Organizations That Can Demonstrate Financial Hardship: Private, non-profit entities that can demonstrate that providing Fish and Wildlife Propagation grant funding on a cost reimbursement basis will create a financial hardship and be detrimental to the operation of the program will be eligible to receive up to ½ of the grant amount after the grant is awarded. The remaining amount of the grant will be disbursed after the entity has submitted information including invoices and receipts documenting how the initial disbursement was spent. Within a year of initial notification of the grant funding award (January 2026), or within one month of project completion, whichever comes sooner, the entity will be required to submit information including invoices and receipts documenting how the second disbursement was spent, and provide a final project report documenting the results of the project.

*Exception For Small Projects Under \$1,000: Grant funding may be disbursed to private, non-profit entities prior to the beginning of the project if the award is under \$1,000 and the entity has provided documentation that the project could only be initiated with advance funding. Within a year of grant funding, or within one month of project completion, whichever comes sooner, recipients must submit a final project report which includes invoices and receipts documenting how funds were spent and the results of the project.

Expenditures from the fish and wildlife propagation fund of any county may be made only for the following purposes:

- (a) Public education relating to the scientific principles of fish and wildlife conservation, consisting of supervised formal instruction carried out pursuant to a planned curriculum and aids to education such as literature, audio and video recordings, training models, and nature study facilities.
- (b) Temporary emergency treatment and care of injured or orphaned wildlife.
- (c) Temporary treatment and care of wildlife confiscated by the department as evidence.
- (d) Breeding, raising, purchasing, or releasing fish or wildlife which are to be released upon approval of the department pursuant to Sections 6400 and 6401 onto land or into waters of local, state, or federal agencies or onto land or into waters open to the public.
- (e) Improvement of fish and wildlife habitat, including, but not limited to, construction of fish screens, weirs, and ladders; drainage or other watershed improvements; gravel and rock removal or placement; construction of irrigation and water distribution systems; earthwork and grading; fencing; planting trees and other vegetation management; and removal of barriers to the migration of fish and wildlife.
- (f) Construction, maintenance, and operation of public hatchery facilities.
- (g) Purchase and maintain materials, supplies, or equipment for either the department's ownership and use or the department's use in the normal performance of the department's responsibilities.
- (h) Predator control actions for the benefit of fish or wildlife following certification in writing by the department that the proposed actions will significantly benefit a particular wildlife species.
- (i) Scientific fish and wildlife research conducted by institutions of higher learning, qualified researchers, or governmental agencies, if approved by the department.
- (j) Reasonable administrative costs, excluding the costs of audits required by Section 13104, for secretarial service, travel, and postage by the county fish and wildlife commission when authorized by the county board of supervisors. For purposes of this subdivision, "reasonable cost" means an amount which does not exceed 3 percent of the average amount received by the fund during the previous three-year period, or three thousand dollars (\$3,000) annually, whichever is greater, excluding any funds carried over from a previous fiscal year.
- (k) Contributions to a secret witness program for the purpose of facilitating enforcement of this code and regulations adopted pursuant to this code.
- Costs incurred by the district attorney or city attorney in investigating and prosecuting civil and criminal actions for violations of this code, as approved by the department.
- (m) Other expenditures, approved by the department, for the purpose of protecting, conserving, propagating, and preserving fish and wildlife.

Referral History:

In 2022, after dissolving the County's Arts & Culture Commission (AC5), the Board of Supervisors directed staff to work towards the development of a public-private partnership and the identification of a non-profit organization to provide arts council services to the County.

The Board established an ad-hoc Steering Committee to guide this process, comprised of representatives of each supervisorial district and representatives of non-profit arts & culture funders. A public planning and engagement effort was then undertaken, led by Arts Orange County-a leading organization in this field, which culminated in the Board's adoption of an Arts & Culture Master Plan for the County, in June 2023.

When the arts council planning and procurement process concluded in December 2023, the Board awarded a 5year contract in the amount of \$1,781,661 to the non-profit organization Independent Arts & Media. The contract is funded by Measure X dollars allocated to arts & culture. (Through Oct. 2024, the County has expended \$471,694 of the contract.)

Independent Arts & Media is the fiscal sponsor of ARTSCCC https://www.artsccc.com/, who are providing the County's arts council services for the period January 1, 2024 through December 31, 2028. Through the Board's recognition in February 2024, ARTSCCC is now the County's State-Local partner with the California Arts Council, which awarded ARTSCCC \$85,500 to date.






