- Make campaign contributions using personal funds
- Attend campaign events on their own personal time.

THE DON'Ts: County Officials and Employees may **NOT**:

- Solicit, directly or indirectly, a political contribution from another county official or employee.
- Distribute campaign literature through the county's internal mail or email system.
- Place campaign literature on county-related websites or elsewhere on county property.
- Do any campaign-related work during compensated work hours.
- Use county facilities (offices, conference rooms) or equipment (phones, computers, printers, copiers, fax machines, email system, paper) for political activities.
- Use official authority to influence voting or other political action.
- Use public funds for any campaign-related purpose.
- Use county seal, logo, or letterhead on any campaign-related communication.
- Participate in political activities while in uniform.

Summary for November 2025

The Blackhawk and Valley Station Deputies either initiated or responded to the following calls for service:

- 467 ~ Total calls for service in Blackhawk
- 4 ~ Total police reports were taken in Blackhawk

Felonies – There was one felony reported in the district.

- On 11/7/25, a resident reported she was the victim of identity theft and credit card fraud. Fortunately, the victim noticed the fraudulent charges quickly, enabling her financial institutions to refund most of her loss. The unknown suspect attempted all transactions via the web. The case was forwarded to Investigations Division.

Misdemeanors – There were two misdemeanors committed in the district.

- On 11/3/25, a hit and run occurred on the corner of Deer Meadow Dr. and Blackhawk Club Dr. A club member parked his vehicle on the corner while having dinner at the country club. Upon returning he noticed his vehicle had been struck in the rear while it was parked, sustaining moderate damage. The person responsible did not leave a note or notify Blackhawk Police Services. The investigation is ongoing.
- On 11/22/25, a DUI occurred near the intersection of Blackhawk Rd. and Blackhawk Plaza Cir. A female driver was stopped for a moving violation and subsequently placed under arrest for DUI.

Arrests – The sole arrest for the month is indicated in the misdemeanor section above.

- There were no significant incidents to report.

Volunteers in Policing

- Our four volunteers provided 21 hours of volunteer work throughout the month. The volunteers provided their routine security checks, including several Vacation House Checks and provided extra patrol vehicle presence throughout the community. In addition to their normal duties, the volunteers staffed the collection site for our clothing drive. Each volunteer spent several hours at the site gathering, sorting and loading trucks with an abundant amount of donations.

A tremendous amount of compassion and generosity was on full display as 5 large truck beds were stuffed full of donations. I would again like to thank all that participated in the drive.
