- 1 Governor's Proposal to Cut \$49.8 Million in Public Health Workforce Development and Training Programs--OPPOSE
- 2 Governor's Proposal to Provide \$35.8 million to Child Support Services--SUPPORT
\$30 million allocation from an existing funding source to support continuity of the CalBridge Behavioral
- 3 Health Navigator program, as well as require the Medi-Cal Community Health Worker benefit to be offered in hospital settings.
- 4 \$140 million for Emergency Services and Disaster Response for County Human Services Agencies
- 5 \$2 million for Bay Point Library & Community Resource Center, \$2 million for Byron Airport Sewer Improvements
