A motion was made to approve the January 17, 2025, minutes. All were in favor.

4. Receive update on the release of the final Contra Costa Refinery Transition Partnership Reports (UCB Labor Center)

The UC Labor Center gave a two-part presentation titled **Just Transition Economic Development Framework & GEZ Priority Technology Research**. The presentation first addressed the findings from <u>Refining Transition</u>: A <u>Just Transition Economic</u>
<u>Development Framework for Contra Costa County</u> and then a GEZ CEM prioritization update.

The baseline challenges continue to be economic inequality and environmental justice.

The report details which jobs and fields are growing and shrinking in Contra Costa. The County continues to suffer from some of the highest rates of pollution in the State and specifically communities that contain low-income people of color. Refinery transition is occurring and is already underway. Additional closures are likely by 2045. This transition will have consequences of loss of quality blue collar jobs, loss of critical local tax revenue, and pollution and cleanup needs. The transition is not the end but can allow efforts to address the underlying challenges of economic inequality and environmental justice.

The three priorities for a just transition are good jobs, healthy communities, and economic resilience.

- 1. Good jobs: Goal of increased quality jobs and ensuring accessibility to opportunity for groups most impacted by refinery transition.
- 2. Healthy communities: Goal of reducing pollution in pollution burdened communities in efforts to improve health outcomes.
- 3. Economic resilience: Goal of reducing economic dependency on fossil fuels production by diversifying industries that greatly affect the county tax revenue.
