Chris Weeks from the City of San Ramon provided a brief update on the status of the Bollinger Canyon Pedestrian Bridge, which is under construction, and Opening of the bridge is expected open this summer. He also spoke of the Crow Canyon Bridge Road bridge, where design is being initiated by San Ramon.

Carl Roner provided a brief update on the San Ramon Double Tracking Project, which is currently in the early stages of design.

Carl Roner also spoke about the Town of Danville's upcoming project to improve the trail crossings at Sycamore Valley Road, Paraiso Drive, El Capitan Drive, and Greenbrook Drive.

Carl Roner provided a brief update on the study implemented by CCTA to connect the north end of the Iron Horse Trail to the Canal Trail in Pacheco and Martinez.

Carl Roner noted that the New and Emerging Mobility Modes in the Corridor Element had gone to the Transportation, Water and Infrastructure Committee on April 30, and was going to the Board of Supervisors on May 20.

7. Consider agenda topics and date for next meeting

The next meeting date is August 11, 2025. Elections will be held for committee chair and vice-chair. Topics to be discussed include the status of San Ramon Double Tracking Project, the construction and opening of San Ramon's Bollinger Canyon Pedestrian Bridge and the design of the Crow Canyon Bridge.

8/9/2022	Flood Control Line F1		Alamo: between South Avenue and Las Trampas Road	The purpose of this project is to address flooding at the intersection of South Avenue and La Serena Court. The proposed project will construct a drainage line that will connect with the existing drainage network and reduce flooding in the area. The newly created drainage line (Line F-1) will consist of a 24" to 30" pipe that will run along the Iron Horse Trail Corridor from existing line Line "F" at Las Trampas Road (1300 ft.), to the intersection of South Avenue. From this point the pipe will extend another 180 ft. to the southwest, to the intersection of South Avenue and La Serena Court where two drainage inlets will be constructed. (Fig.1) Line F-1 will be added to Drainage Area 13.	Flood Control has finalized pipe alignment working with utility agencies (i.e., Kinder Morgan, CCCSD, EBMUD.) The preferred alignment is between KM line and CCCSD line. Planning has been completed. The project will be sent to Design when their availability improves.

Air sparging/soil vapor extraction was not particularly effective in cleaning up the site. The RWQCB has approved monitoring and natural attenuation as a potential remediation method. They will be evaluating this over the next few months. (Ongoing) Floating product continues to be found in the immediate vicinity of the spill, but has mostly dissapated at any distance from the spill site. Petroleum products are not being found in surface water. The floating product is being removed manually when the wells at the source are sampled.
