Justice in Aging provides education (trainings, webinars, publications). administrative advocacy, and litigation.

Areas of expertise: 1) health care (i.e., Medicare, MediCal, IHSS), 2) housing (maintaining accessible and affordable housing, tenant rights), 2) income and economic security (social security, SSI, CAPI, CalFresh), 4) elder rights (elder abuse, neglect, alternative to conservatorship), 5) language and disability access, and 6) legal services capacity building.

The fastest-growing population experiencing homelessness are older adults.

Racial Equity and Homelessness

Homelessness is linked to racial inequities.

Black or African American Californians experience homelessness disproportionately (26% of unhoused population 50+). Same for American Indian or indigenous people.

Disparities in social determinants of health (economic stability, neighborhood environment, education, food, community and social context, and health care system) drive homelessness.

Barriers to Equity

Housing barriers - redlining, segregation, government subsidies of white communities and displacement of communities of color.

Educational - lack of access to education and disparities in education funding.

Economic - historically pushed into undervalued and underpaid jobs, lower likelihood of robust retirement plans connected to work.

Health - Chronic health conditions due to environmental factors, bias in health care system.

Justice system involvement

Equitable Solutions Needed

Focus on homeless prevention as an elder justice issue.

Rent subsidies, implementing renter protections in all settings.

Continue to explore and fund Medi-Cal housing support.

Remove barriers to personal care services.

Increase coordination among agencies to prevent homelessness.

It is working on affordable housing solutions and ADUs, transportation resources including EV ride-sharing pilot, bike paths, and "walk on streets" project to document infrastructure issues such as missing sidewalks, and inadequate lighting and transit. Dear Assemblymember Ward,

On behalf of the Contra Costa County Advisory Council on Aging, I am writing in strong support of AB 474, the Home Sharing Act of 2025. Our council advises the Board of Supervisors on matters related to older adults in our county. Please note that the views expressed here are those of the Advisory Council and do not represent the official position of Contra Costa County or its officers.

AB 474 offers a smart, cost-effective solution to address California's growing housing crisis, especially among older adults. By encouraging and supporting home sharing programs, your bill provides dual benefits: helping low-income older homeowners remain in their homes while creating affordable rental opportunities for others in need.

As the population of Californians aged 60 and older grows rapidly, housing insecurity among this group - especially those with limited incomes - has become an urgent concern. AB 474 addresses this by allowing homeowners to rent out excess or vacant bedrooms without jeopardizing their eligibility for public assistance. The bill's exemption of rental income from income tax is a meaningful support for older homeowners.

The Home Sharing Act also protects tenants' rights while maintaining the homeowner's ability to bring in a caregiver when needed. These balanced provisions make AB 474 a "win-win" for both parties.

We appreciate your leadership on this issue and your commitment to innovative, compassionate solutions. Thank you for sponsoring AB 474 and working to expand affordable housing options while helping older adults age in place with dignity.
