4. Chief of Police Report – May '25

a. 374 Calls for Service: 10 Reports, 1 Felony, 1 Misdemeanor

b. Felony:

Residential Burglary – Different from previous burglaries in the community. Suspects gained access through the roof into the attic, then cut a hole in the ceiling and dropped into the primary bedroom. Cash and jewelry were taken from a small safe in the primary closet. A motion alarm in the closet was activated and suspects fled out a window leaving numerous tools and equipment. Deputies arrived within minutes, but suspects had fled the area. Alarm placement and activation mitigated greater loss.

c. Misdemeanor

Domestic Battery – Husband struck his wife during an argument. Husband was arrested and booked at the Martinez Detention Facility.

d. There were two arrests in May 2025.

One was the misdemeanor listed above, and the other a male was arrested for an outstanding warrant issued from Napa County during a traffic stop.

- e. Volunteers in Policing: 21 hours served by four volunteers.
- f. Deputies have been responding to teenaged children riding bikes (usually e-bikes) on the golf courses. The Chief reminded the community that the Golf Courses are Country Club property and that unauthorized access is trespassing. Anyone caught who has caused damage to the course could face vandalism charges. The Chief asks that parents talk to their children and remind them about appropriate places to ride their bikes and potential consequences.
- g. Coffee with the Chief scheduled for June 18, 2025 (9:00am – 11:00am) at Blackhawk Drive and Blackhawk Meadow Drive.

5. C.H.P. Report

No crashes inside the gate. A few on Camino Tassajara where drivers appear to be running stop signs. CHP volunteers are driving in the area, hopefully making a difference.

- c. Linda Kralik – With children out of school, many more e-bikes on the road and not following the rules of the road. Concerned about driving on the wrong side of the street, stop signs, and no helmets. Chief has directed Officers to stop and cite when appropriate.

Summary for June 2025

The Blackhawk and Valley Station Deputies either initiated or responded to the following calls for service:

- 348 ~ Total calls for service in Blackhawk
- 5 ~ Total police reports were taken in Blackhawk

Felonies - There were 2 felonies reported in the district.

- On 6/7/25, A resident reported she was the victim of identity theft. Wells Fargo informed the victim an unknown suspect used her identifying information to access her checking account and make a withdrawal remotely. Wells Fargo returned the funds and opened their own investigation. The case was also forwarded to Investigations Division.
- On 6/13/25, A domestic battery occurred. Following an investigation the husband was arrested for domestic battery and booked at the Martinez Detention Facility.

Misdemeanors - There were no misdemeanors reported in the district.

Arrests – The sole arrest for the month is noted in the felony section above.

Incidents of Interest

- On 6/4/25, at approximately 6 p.m. a fire hydrant was damaged at the entrance to the Plaza. The damage caused a geyser of water that ultimately led to a traffic back up. Traffic on Blackhawk Rd. was diverted for nearly an hour while SRVFD stopped the flow of water and repaired the hydrant. CHP responded to determine if the damage was caused by a vehicle.
- On 6/21/25, at approximately 6 p.m. a child was reported missing in unincorporated Danville. A 9-year-old autistic child left his home near the area of Charbray St. and Camino Tassajara and was not immediately located by his parents. Valley Station Deputies, Danville PD and Blackhawk Deputy Macias responded to the call and

immediately began a search for the boy. When not located, additional resources were activated to help in the search. These resources included members of the Sheriff's Department's Search and Rescue and air support services consisting of the Sheriff's Department helicopter and drones. Several Nixle alerts were also broadcast throughout the community.

The presence of these resources and alerts drew attention from many throughout Blackhawk, as many residents assisted in the search as well. With the help of community residents, the young boy was located the following morning at approximately 8 a.m. The boy was seen by a resident in Alamo Creek, near Kingswood Ln. Deputy Macias and SRVFD responded to the location and contacted the child. Although out the entire night and morning the child was safe, and unharmed. After being medically cleared by SRVFD the child was reunited with his parents.

I would like to extend a special thank you to all those who took it upon themselves to help search for this child. Your efforts brought a traumatic and stressful situation for many involved to a successful and joyous outcome.

Summary for July 2025

The Blackhawk and Valley Station Deputies either initiated or responded to the following calls for service:

- 563 ~ Total calls for service in Blackhawk
- 8 ~ Total police reports were taken in Blackhawk

Felonies - There were 2 felonies reported in the district.

- On 7/21/25, a resident reported they were a victim of identity theft. The suspect was an in-home care taker for the victim and used the victim's bank account information to pay personal bills. The suspect has been identified and charges have been filed.
- On 7/26/2025, a resident reported they were a victim of grand theft. Much like the above crime, the suspect was an in-home care taker for the victim. After the suspect abruptly quit her job taking care of the victim, the victim realized she was missing several pieces of expensive clothing and jewelry. Confirmation of the suspect's identity and whereabouts is being investigated by detectives.

Misdemeanors – There were 3 misdemeanors committed in the district.

- On 7/10/25, at approximately 8 p.m. a vehicle struck the iron fence on Blackhawk Rd. near Maplewood Dr. the vehicle fled prior to police arrival. An investigation into the vehicle and driver responsible is ongoing.
- On 7/19/25, at approximately 2 p.m. a vehicle was seen driving recklessly while leaving a car show inside Blackhawk Plaza. The driver was stopped on Camino Tassajara and arrested for reckless driving. The driver was issued a citation, and his vehicle was impounded.
- On 7/31/25, a domestic disturbance occurred. Two adult males were involved in an argument that turned physical. Deputies responded and separated the parties involved. Neither party requested prosecution and a report was written.

Arrests – There was one arrest for the month, indicated in the second misdemeanor above.
