- 2. Public Comments, recognize & acknowledge the Public's participation via Zoom
- 3. Review and Approve Draft Record of Actions for February 11, 2025 meeting Robert Durr- Motion, Roger Guidi- Second
- 4. Chief of Police Report February '25
 - a. Update on Budget / current fiscal year: Still looking for a third BH Officer. Filling the vacancy with overtime for now. All shifts are being covered currently. No date to fill the vacancy, but Officers are eager for the overtime at the S.O.. b. 308 Calls for service: 6 Reports, 2 Felonies, no Misdemeanors, and no Arrests.
 - c. Felonies included:
 - 1) Commercial vandalism at the Plaza Large second floor window broken with an unknown object.
 - 2) Auto burglary at the Plaza A purse was left on the vehicle's floorboard. Suspect(s) smashed a window, stole the purse and fled the scene. A suspect vehicle was identified, located and a pursuit ensued. The pursuit was cancelled for public safety, and the vehicle was later recovered as abandoned. Most of the Victim's property was recovered. A suspect was subsequently identified. Investigation continues.
 - b. There were no misdemeanors in February 2025.
 - c. There were no arrests in February 2025.

- d. Volunteers in Policing: 18 hours served by four volunteers.
- e. One accident vehicle vs fixed object
- f. Coffee with the Chief scheduled for March 19, 2025 at Blackhawk Drive and Blackhawk Meadow Drive (weather permitting).

5. C.H.P. Report

Numbers from Jan 1st to today 158 misdemeanor arrests with 124 of those being DUIs (most on the freeway and on weekends), 21 felonies to date. Some accidents on Camino Tassajara, but not in this area. CHP volunteers are driving in the area, hopefully making a difference. Glad for CHP presence!

6. Homeowner Association Report

Nothing to report. Does the gate track those required to U-Turn when they are not valid visitors. The repeat offenders and those who "sneak" in through the out gate instead of making the U-Turn, license plates are collected and trespass reports and/or citations are issued as appropriate.

and BH Officers are making patrols in the area. Chief asking if residents see something or people in the open space, report it.

Linda Kralik— Inquired about a Ring system? Could those assist? Good resource, but not the end all/be all. They do provide some of a deterrence factor. Most suspects are pretty well covered up and difficult to identify them even with the cameras.
