3. PUBLIC COMMENT (3 minutes/speaker)

- At the committee's request, Alamo Rotary representatives returned to provide clarification and historical context regarding maintenance challenges at the I-680 cloverleaf/intersection sites.*
- Unlicensed dumping of vegetation and debris continues at these locations. A proposal by Chip Chapman (Horticultural Services LTD) to provide wood chips was discussed, with the committee agreeing to request clarification on chip quality and to require immediate spreading rather than leaving piles onsite.*
- Rotary explained that these sites were originally adopted as a community service project, but CHP jurisdiction and safety regulations now significantly limit volunteer access and maintenance activities.*
- While community volunteer involvement was discussed, CHP safety requirements and access constraints present ongoing challenges.*
- Kirk Bennett was designated as the point person to coordinate next steps and explore potential solutions.*
- It was noted that other counties (e.g., Orange County) maintain similar sites successfully, though their methods are unclear.*

November and December 2025 Record of Actions were reviewed and approved.

5. POLICE REPORT

A residential burglary was reported in which the suspect stole approximately \$1,800 in jewelry. The suspect is believed to have arrived and departed on foot. No video evidence was available; however, DNA evidence was collected and may assist with identification in the future.
