## AMENDMENT TO AGREEMENT

THIS AMENDMENT TO AGREEMENT (this "Amendment") is made and entered effective September 1, 2024 (the "Effective Date"), by and between VIZIENT SUPPLY, LLC, a Delaware limited liability company ("Vizient"), and HOLOGIC SALES AND SERVICE, LLC, a Massachusetts limited liability company ("Supplier"). Vizient and Supplier are sometimes referred to herein individually as a "Party" and collectively as the "Parties".

**WHEREAS**, Vizient and Supplier entered into that certain Agreement XR0653, for Mammography Equipment, dated September 1, 2020 (as may be amended from time-to-time, the "Agreement"); and

**WHEREAS**, the Parties desire to amend the Agreement pursuant to the terms, covenants and conditions set forth in this Amendment.

**NOW THEREFORE**, in consideration of the mutual covenants and conditions hereinafter expressed, the Parties agree as follows:

- 1. <u>Recitals</u>. The foregoing recitals are incorporated herein by this reference as fully set forth at this point in the text of this Amendment.
- 2. <u>Defined Terms</u>. All capitalized terms used in this Amendment shall have the same meanings given such terms in the Agreement, unless otherwise defined in this Amendment, and all terms defined in this Amendment and not defined in the Agreement are hereby incorporated into the Agreement for all pertinent purposes, unless otherwise stated.
- 3. <u>Amendment of Agreement</u>. The Agreement is hereby amended as follows:
  - A. Extension of Term. The Parties acknowledge and agree that the Agreement (prior to any modifications pursuant to this Amendment) currently expires on August 31, 2025. Subject to the terms and conditions set forth in this Amendment, the Term of the Agreement is hereby extended to August 31, 2027. For purposes of clarification, the Agreement shall not automatically renew past August 31, 2027 without the mutual agreement of the Parties.

## 4. <u>Miscellaneous</u>.

- A. Vizient and Supplier each represent and warrant to the other that the person signing this Amendment on its respective behalf has the requisite authority and power to do so, and to thereby bind the Party on whose behalf such person is signing.
- B. This Amendment may be executed in a number of identical counterparts which, taken together, shall constitute collectively one agreement.
- C. Except as herein expressly modified, all terms, conditions and provisions of the Agreement shall remain in full force and effect. To the extent of any inconsistency between the terms and conditions of the Agreement and the terms and conditions of this Amendment, the terms and conditions of this Amendment shall govern.
