Description of Proposed Equipment/System:

CompuMail will be leveraging four (4) Bluecrest Vantage high-speed MLOCR sorters with 480 bins, two (2) Blucrest Apex high-speed MLOCR sorters with 480 bins and two (2) Bluecrest Vantage MLOCR flat sorters with 168 bins.

Additionally, CompuMail has four (4) Bluecrest MPS high-speed 4-station inserters with DC Verify. Two inserters can handle continuous feed, while two can handle both continuous feed and cut-sheet input.

CompuMail has two (2) Canon ColorStream 3900 high-speed ink-jet printers with dual towers for in-line duplex printing.

Proposed Implementation Plan and Schedule:

CompuMail is currently performing presort services for the Contra Costa County Public Works – Print and Mail Division. As such, unless additional locations and/or new mail type streams are introduced, CompuMail intends to maintain the current in-place workflow which would require no implementation or schedule.
