I am writing to you in regards to the Fish and Wildlife Propagation Fund grant for the John Muir Chapter of Trout Unlimited for the "Wildcat Creek Water Quality and Fish Habitat Monitoring Study" approved by the Board of Supervisors on February 27, 2024.

Although it is an integral part of our grant proposal as included under the *Project Schedule* as "Maintain and Replace Hobo Loggers...", we did not specifically indicate a cost for factory replacement of batteries as needed. These Hobo monitors are soon requiring battery replacement which can only be done by the manufacturer (Onset Computer Corporation) in Massachusetts. Battery replacement for all of our three monitoring units will cost \$849.88 including tax and shipping.

We are requesting that the Commission approve, without change in total funding, a modification to our budgeted expenses. With this approval we will utilize certain funds previously allocated for 1) Replacement DO sensor caps, 2) Shipping and 3) Miscellaneous supplies to enable us to replace batteries on our monitors thus allowing us to continue this project as previously approved.

1. Activities and Accomplishments The Fish and Wildlife Committee met six times to discuss matters related to fish and wildlife in Contra Costa County (CCC). The Committee administered a grant program that expends the Fish and Wildlife Propagation Funds (funds that are collected by the CA Department of Fish and Wildlife for code violations). Additional details on the Committee's activities are provided below.

Grant Program: The Committee reviewed 12 proposals, interviewed applicants and selected of the proposals for full

Outreach: 1) The Committee hosted the annual Fall Forum on September 26<sup>th</sup> at the Martinez Yacht Club and via teleconference for those who wished to join remotely. The Forum was open to the public and invitations encouraged people involved in fish and wildlife law enforcement issues in CCC to attend. Invited attendees included representatives of the U.S. House of Representatives, California Senate and State Assembly, the California Department of Fish and Wildlife, Sheriff's Department, District Attorney's Office, Superior Court, Public Defender's Office, the East Bay Regional Park District Police, the Board of Supervisors and members of the public. Past participants have indicated that the Fall Forum has been helpful in raising awareness and fostering cooperation on fish and wildlife issues and law enforcement. Approximately 100 people attended the event in 2024. 2) Distributed Wildlife in Your Backyard brochure.

<u>Volunteer Activities:</u> Several members volunteered in the community with other organizations that are interested in fish and wildlife issues. A sample of these volunteer activities include: Roni Gehlke – California Water Environment Association (CWEA) - State Division Chair of the Community Engagement and Outreach Committee, committee member of the CWEA San Francisco Bay Section Communications Committee and committee member of the CWEA State Division Education Committee; Susan Heckly - Lindsay Wildlife Experience, CCC Master Gardener, International Wildlife Rehabilitation Council and the FWC representative on the CCC Integrated Pest Management Advisory Committee; Kathleen Jennings – Co-chair of the Peyton Slough Wetlands Advisory Committee; Danny Pellegrini - Contra Costa Mosquito and Vector Control District Board of Trustees - Secretary, Sheriff's Posse of CCC (Barbeque Captain) and the Martinez Sportsmen's Club.

Committee members were regularly updated on activities related to fish and wildlife in CCC, which included six presentations which are listed below:

- Two presentations on the Bringing Back the Natives Garden Tour and how native plants benefit wildlife. (Kathy Kramer, Bringing Back the Natives Garden Tour)
- Presentation on Envision Contra Costa (Jody London and Will Nelson, CCC Department of Conservation and Development)
- Presentation on the Alhambra Educational Mural Featuring Local Flora and Fauna. (Victoria Woolfolk, Contra Costa Resource Conservation District)
- Presentation on abandoned vessel abatement in Contra Costa County waterways and other Marine Patrol environmental enforcement responsibilities. (Douglas Powell, Contra Costa Sheriff Marine Patrol Unit)
- Presentation on the status of the eDNA Monitoring of the Restored Livestock Ponds project. (Ben Weise, Contra Costa Resource Conservation District)
- 2. <u>Attendance/Representation</u> The FWC is composed of ten members. Each County Supervisor appoints a member and the Internal Operations Committee appoints four At-large members and one At-large Alternate. The FWC met six times at which a quorum was always present. One meeting was cancelled due to lack of a quorum. The members were: Jamin Pursell (D-I), Susan Heckly (D-II), Jarrod Bolliger (D-III), Brett Morris (D-IV), Daniel Pellegrini (D-V), Roni Gehlke (Atlarge), Kathleen Jennings (At-large), Nicole Balbas (At-large), Cass Rogers (At-large), and Felipe Solis (At-large Alternate). The District III and At-large Alternate seats are currently vacant.
- **3.** <u>Training/Certification</u> All members have viewed the required Brown Act & Better Government Ordinance, Ethics Training, and Implicit Bias videos. Certifications are on file for all of the members.

## 4. Proposed Work Plan/Objectives for Next Year

## (a) FWC Operations:

- Develop and refine Work Plan (working document).
- Maintain FWC membership by advertising vacancies and forwarding applications to the Internal Operations Committee.
- Seek to coordinate with other Fish and Wildlife Committees on regional matters.
- Coordinate with the Contra Costa Watershed Forum.

# (b) Make recommendations to the Board of Supervisors via the Internal Operations Committee for the appropriation of funds from the Fish and Wildlife Propagation Fund to support fish and wildlife projects in the community:

- Conduct grant program to solicit proposals, evaluate their relative merits, and recommend funding for projects which will contribute most to the fish and wildlife resources of the County.
- Develop and advertise FWC grant program by: 1) reviewing past Request for Proposals (RFP), funding applications; and 2) developing new RFP, funding application deadline, and funding priorities; and 3) posting to the County and Department of Conservation and Development websites and social media sites, distributing these materials to the media, the FWC and Contra Costa Watershed Forum mailing lists, and to anyone who requests them.
- Work with agencies, organizations, and individuals to help them plan and develop projects suitable for support from the Fish and Wildlife Propagation Fund.
- Monitor the efficiency and effectiveness of the grant disbursement process.
- Review funding applications received. Make recommendations to the Board of Supervisors via the Internal Operations Committee for the awarding of grants.
- Follow-up on projects that receive funding to assure that projects proceed as proposed. One way the FWC will do this is to extend invitations to prior Fish and Wildlife Propagation Fund Grant recipients to future meetings to give status reports, outcomes and presentations regarding their projects.

## (c) FWC priorities for 2024/2025:

- Make recommendations to the Board to approve Fish and Wildlife Propagation Fund grant applications for
  projects that increase collaboration with law enforcement agencies, the court, and community cultural
  organizations on enforcement issues and increase education focusing on communities that may be unaware of local
  fish and game laws.
- Provide public forum opportunities for open discussion on wildlife issues that affect CCC residents and impact natural resources in our County, increase outreach efforts and provide advisory updates to Board of Supervisors as needed.
- Disseminate "Wildlife in Your Backyard" booklet and develop other projects for involvement of the FWC and the community in CCC.
- Develop a resource document regarding invasive species.
- Update website with information on invasive species and a list of awarded Fish and Wildlife Propagation Fund grants.

# (d) FWC projects (develop and prioritize a list of projects for potential FWC involvement; select projects for FWC involvement and provide appropriate support, including: initiation, planning, consultation, and/or funding):

- Make recommendations to the Board on awarding Certificates of Appreciation for significant contributions to the fish and wildlife resources of the County.
- Consider hosting a forum about wildlife.

# (e) Improve enforcement of fish and game laws and regulations; increase flow of money into the Fish and Wildlife Propagation Fund:

- Help assure that, when appropriate, a portion of fines from violations of laws designed to protect fish and wildlife resources is deposited in the Fish and Wildlife Propagation Fund. Promote awareness of the harm caused by violation of fish and wildlife regulations and the value of enforcement.

Responses to questions from the Fish and Wildlife Committee from Peter Flowers, Wildlife Hospital & Rehabilitation Manager, Lindsay Wildlife Experience

1. Where on the property will the mammal pen be housed?

The pen will be located in the "corp yard". A fenced-in area at the back of the property where there are several other aviaries already. The plan involves the removal of a portable metal storage pod currently on site and placing the pen in that location. The pod and the pen are the same size so we know that there is room

2. What other already existing mammal pens are at Lindsay and in Contra Costa County?

Currently Lindsay Wildlife has no mammal holding space on site and we are dependent on our homecare volunteers to provide space. CDFW regulations are changing next year and we are attempting to bring ourselves up to the new regulation requirements. Homecare volunteers providing space in their yards will no longer be acceptable under these regulations without major expansion and expense in addition to it being acceptable under each homeowner's city, county and HOA restrictions. Lindsay Wildlife is also the only Wildlife rehabilitation hospital in Contra Costa County.

3. What is the rationale for a mammal pen on site?

Please see above for a response to this.

4. Clarify whether this is an aviary or a mammal pen.

Mammal Pen

5. What animals are authorized for this size pen?

All size appropriate species that Lindsay Wildlife is currently permitted to have by the California Department of Fish and Wildlife that require outdoor holding space as part of their rehabilitation. This includes Eastern fox squirrels, California ground squirrels, Western grey squirrels, Virginia Opossum, Northern raccoon, Grey fox, Juvenile coyotes, skunks (overnight holding only), Fawns (overnight holding only), Badger, River Otter, Cotton-tailed rabbits, Brush rabbit, Black-tailed jack rabbit. This pen would not be an appropriate holding space for very small mammals like native mice, voles or gophers.

6. Is this for pre-release or medical holding?

Pre-release conditioning as needed and required by CDFW regulations.

7. Need breakdown between labor and supplies.

The pen is already owned by Lindsay Wildlife and is sitting disassembled in our corp yard. It is new and never used, previously donated. We knew however that it would take extra work and cost to put it up in an appropriate place. Most of the cost is expertise and labor.

The estimate from Contra Costa drain and plumbing is to trench and place a drain from the pen to the sewer.

The estimate from A&L is to erect the pen and place protective pet mesh on it as required by CDFW. Total estimate includes Labor for installation. All materials are already on site.

I have attached the estimates they provided.

The cost of the new storage unit is pure supply cost as it is a pre-fab unit and will be erected by us.

I guess my question is do I need to ask the companies providing the estimates to break down their estimates between labor and supplies. I can ask them to do that.

Thank you so much for your consideration. Please let me know if you need anything else.

## 10/8/24 Update

The A&L landscaping estimate is all labor as we are providing the supplies since we already have the pen.

We emailed COCO County plumbing last week and have been waiting for a response. I will push to get one by tomorrow.

## 10/9/24 Update

I received the updated estimate for the drain work to include the labor vs supplies.

Unfortunately, as we asked them to revise the estimate, they also increased the cost since the original request and as there is a long lag time between the original ask and when the work would actually happen.

Obviously, Lindsay may have to pay the additional since it wasn't included in the grant request.

I can if needed also revise the grant request.

Our quotes for the entire project equal \$28,809 without labor. This is a steep cost, but we are limited on our ability to create accessible and professional exhibits in-house. As a small non-profit, we run on minimal staff. Our operations department consists of one person who's job is building maintenance, and our exhibits are created by our education department. We do not have in-house fabrication capabilities and many of the elements in our design require physical labor that is beyond our ability. Our entire education staff is highly educated and brilliant at coming up with concepts to engage the public and facilitate conservation messaging, but we lack the skills and tools to make our exhibits happen without outside contractors. Part of our current mission is to make Lindsay Wildlife Experience accessible to all visitors and that does make projects more costly. Our Bear Dean vision includes many touch elements to engage neurodivergent and vision-impaired visitors. Our 2025 grant seeks funding of \$20,000 to allow us to fully realize our vision, and Lindsay Wildlife Experience will fund the other \$8,800.

We are the only Wildlife Education Center in Contra Costa County, and we serve over 80,000 visitors annually. Our school programs reach over 10,000 children in Contra Costa County, and we annually provide 50 grantfunded school programs to Title 1 schools in Contra Costa County, as well as providing camp scholarships to deserving families. Your generous funding would help create conservation messages that can help residents of Contra Costa County understand the impact they have from home on a global scale.
