Nicole Green, CAB Chair, provided an update of the CAB's proposed policy and budget recommendations for FY26-27. Included in the presentation were major highlights of programs funded by AB 109, data collection activities, and general updates from each CAB subcommittee. In addition, a recommendation was proposed to fund a lived experience seat on the CAB with a stipend. Due to recent County policy updates to monetary incentives, including participation of volunteers on Board commissions and advisory bodies and the need to inventory other commissions and advisory bodies with stipend seats, the Partnership asked that staff look into the topic for future discussion.
