Welcome, Establish Quorum, and Introductions:

The meeting began promptly at 10AM with Seth welcoming everyone back from the summer break. Council members and guests attended either in-person at 1025 Escobar St. in Martinez or on Zoom. Spanish interpretation was offered to those on Zoom. Guests introduced themselves and Zoom folks entered their names and affiliations in Chat for attendance purposes. Vi introduced new board members Matt Bell and Erik Estrada. Roll was taken and quorum was established. The meeting minutes for May and June 2025 were approved with two abstentions (Christine and Will) (M/Will, S/Nickole). There were no changes to the agenda.

UPDATES:

RCEB - Rebecca Nanyonjo

Dr. Becky reported there are talks of major cuts if there are no changes to the federal HR1. If California steps in to rescue its own budget, there could be penalties. She met with Congressman DeSaulnier for a 30-minute podcast interview where she talked about challenges with bureaucracy and potential impacts on safety net systems. She is anticipating significant financial changes in 2026 and will continue to advocate strongly.

Blue Moon Living Facility, a new fully accessible home for people who are deaf or hard of hearing, opened in August. It's the first of its kind in the state. RCEB is seen as a leader for supporting the deaf community, and this home could set an example for others across California. Also, she had a chance to connect with leaders in the deaf community at the Fremont Deaf Conference that was co-hosted by RCEB and GGRC.

On September 27th, RCEB launched its first community listening to hear how they can improve. Parents and people served are welcome to share feedback. Here is the schedule of upcoming [Community Listening Sessions](#)

Dr. Becky also shared DDS updates from the delegating team meeting held in Irvine:

- Rate reform is well underway. The new DDS director, Pete Cerivinka, is focused on outcomes and compliance. Providers must meet deadlines for requested information or face penalties.
- State budget for service professional training (DSPs) was restored.
- SDP costs are much higher than expected and the state is working to control them. New rules will appear in upcoming trailer bill language. The financial climate is tough, especially with a federal administration that's not supportive. California's flexible budget has led to some very high costs, citing an example of a provider billing at \$1,000 per hour.
- Governor Newsom rejected proposed limits on overtime for IHSS.

Questions/Comments

- A comment on ballooning SDP budgets; when one is not being served or well, it should be expected that costs will increase.
- A request was made to share the link to the DeSaulnier podcast.
- A question was asked if HR1 will affect SSI and food stamps. Yes, it will affect public benefits. It will NOT impact social security, as of right now.

SCDD Bay Area Office – Sheraden Nicholau

Sheraden accepted a new role as Deputy Director of Regional Operations, focusing on programs and systems. She'll still be available to the community and is seeking excellent candidates to replace her. Gabriela Solval had a baby girl in late July and is planning to return to the Bay Area Office in early 2026. Gabriela and baby are both doing very well.

The State Council is collecting your input for California's next 5-yr State Plan, for 2027-2031. They are asking community members to complete the survey, and share the online survey portal, and if possible, join their upcoming town halls to hear more about how your input in years past has shaped the Council priorities, and how your input will help build the next 5-yr state plan. Council Chairperson – Seth Hendricks

Seth reported that the summer planning resulted in 3 priority areas the Council will focus on for 2025-2026:

1. Early childhood and school aged children
2. Supporting independence
3. Long term planning

Executive Assistant to the Council – Vi Ibarra

Vi shared an update from CCHS. As of October 1st. MediCare will no longer bill for telehealth visits. This was already planned and not part of the HR1 bill. This is good information to know in case you or someone you know had a telehealth visit that was cancelled. Thank you Jason for bringing the refreshments today!

Membership – Troy Russell No report.

Community Liaison Reports:

Early Start Provider – Christine Rottger

This new report has been added to work towards getting more input on Early Start. It is challenging for families with really young children to come to this meeting. Christine will be reporting out things that impact the early start community including information shared during RCEB's early start provider meeting, DDS's interagency coordinating council on early intervention, and also the infant development association for California.

East Bay Legislative Coalition – Will Sanford

Several assembly bills await the Governor's signature by mid-October. These include:

- Allowing licensed day programs to provide inhalable anti-seizure medications (passed, not yet signed),
- Improving access to state parks,
- Dr. Arambula's bill for technical assistance with oral health treatments,
- Stopping auto insurance companies from classifying providers as common carriers during work,
- Allowing Licensed Vocational Nurses (LVNs) to support students in schools,
- Creating an ombudsman office for the Department of Developmental Services (DDS).
- Sharing information between state departments (DDS, DSS, etc.), which currently work in silos, and
- Installing pedestrian crossing signals friendly to people with access and functional needs.

Will encouraged everyone to visit local legislative offices and share your story about the services you receive or how dental care or SDP has helped you. Right now, things seem stable, but challenges are coming with HR1's complex service requirements. Many new legislators don't know about our service system's past struggles. The time is now to build relationships with our local lawmakers.

Other issues to be aware of:

- Covered California subsidies will end in December, so premiums will rise.
- A partial shutdown of the Federal government may start October 1st, which will impact non-essential services.

EBLC will host a townhall meeting on January 30th, from 10AM-noon that will include a reverse townhall and video testimonials. The location is to be determined.
