Joining the committee has been a goal of mine for quite some time. I've worked in ECE for 30 years. I've experienced the hardships of learning to be a teacher, achieving higher education, and not seeing the change needed to equip teachers for the influx of children with atypical development and trauma. Often, teachers have difficulties shifting theory into practice. Teachers are leaving our educational institutions, needing to fully understand the depths of the ecological systems and how they influence the ECE environment. That said, I have made it a personal mission to teach incoming teachers and share my successes and challenges. I am still actively engaged in ECE classrooms, working with staff to create individualized strategies for both the child and their families. I strongly believe that to create change, we must use our voices to advocate. I teach this lesson to all of my ECE students. One change I firmly believe in is that ratios need to be revised. Ratios do not reflect the current evolution of children. We have children with high needs, and the teachers are struggling to provide what's necessary to care for them. Our policymakers have yet to work day-to-day in these classrooms, so there is a detachment from the current ECE climate. Teachers' wellness is an underrated and overlooked foundation linked to children's educational success and experience. Studies show that teachers' wellness directly impacts children's overall outcomes. I know because my Master Thesis is Put Your Oxygen Mask on First.
