Tech Funding: (Standing Item):

Access to Technology (ATT) Grant from CDA - \$1,440, 700:

Contract period 10/1/22 - 9/30/24

Scope of Work approved by CDA to include: CC Public Health - \$800,000 to distribute devices to unhoused and low income individuals, General Assistance clients and APS referrals. Plus 4 tech labs at Senior Centers who agreed to offer classes and training from staff/volunteers. Senior Centers: Pittsburg Senior Center -\$33,000, North Richmond Senior Center - \$28,500, Oakley Senior Center - \$28,500 and San Pablo Senior Center - \$30,000. Only Oakley Senior Center and Pittsburg have executed contracts with CC. North Richmond and San Pablo withdrew participation. Community Tech Network's contract has been amended - \$764,861. The will distribute a total of 600 iPads and provide digital literacy training to older adults.
