- **a. Supervisor Glover** Armando reported that the Spring clean-up went well. 114 people came to participate. We were able to accept tires this time. Member suggested we have people to help people unload who were unable to do so themselves. We are hoping to get the Adopt-a-Road program re started post COVID.
- **b.** Contra Costa Sheriff Deputy Diaz reported calls were lower in October. The number of stolen vehicles has dropped. Issues was raised about the increase in food trucks and pop up kitchens restricting use of sidewalks.
- **c. Public Works** Larry Tolson and Bill Lovan were introduced as our new Code Enforcement officers. Larry had worked the Bay Point area in the past. payments she said that they would not.

- **c.** Ambrose Recreation and Park District, Lori Chalifoux, General Manager: A general report about increasing programs and enhancing parks, no details given.
- **d.** Military Ocean Terminal Concord (MOTCO) David, Chief of Police: MOTCO is one of only two of its type of facility in the Country, the other is in San Diego. They have plans to use more of their vacant areas. The question was raised about the Gate 5, the truck entrance, being possible as an emergency exit for the Bay Point community during an evacuation order, like the one this summer. He said he thought it might be something that we could work out.
- **9. Members Reports:** Member Garcia-Lopez said there was a new store at the center at Port Chicago Highway and Pacifica Ave. and encouraged people to shop there. She could not recall the name of it.
