Who Are Caregivers?

- Unpaid individuals providing assistance to family members or friends
- 52 million Americans provide care each year to other adults
- 14.9 million care for someone with dementia

Care Provided

- 96% — ADLs/IADLs
- 46% — medical/nursing tasks
 - Medications
 - Assistive Devices
 - Incontinence
 - Wound Care
 - Training
- Cultural tasks

Impact of Caregiving on Health

- High rates of mental health problems
40-70% experience symptoms of clinical depression
- 84% spousal caregivers had no health visits
- Only 28% of spousal caregivers had help from family
- Only 12% have used respite
- 78% report needing more help and information

Helping Caregivers Access Support Services

- Assess caregiver and family system for emotional/mental health needs
- Assist caregiver in self-identifying emotional/mental health symptoms and refer to appropriate services
- Implement interventions which support caregiver competency, confidence, decision-making

 - Dementia/Alzheimer's
 - Parkinson's
 - Stroke
 - Multiple Sclerosis (MS)
 - Amyotrophic Lateral Sclerosis (ALS)
 - Brain Injury
 - Huntington's Disease
2. Family caregivers of adults age 60 and older regardless of diagnosis or income level in **Alameda, Contra Costa, San Francisco, and San Mateo** counties

- When you call FCA, a program associate will:
 - respond within 24 hours if not immediately available;
 - listen to your situation and respond to questions;
 - provide emotional support;
 - make targeted referrals to community agencies and send a packet of information to you if needed;
 - refer you for a free family consultation.

Family Consultation

- Family Consultants are professionally trained clinicians. They can meet with caregivers and assist them to:
 - understand the symptoms of a specific diagnosis;
 - plan for current and future needs;
 - help you access community resources;
 - problem solve for caregiver challenges;
 - access ongoing support and assistance;
 - access additional FCA services.

FCA Respite Options

- Camp for Caring — a weekend retreat for persons with memory loss that offers:
 - a structured activity program with meals and snacks;
 - staff supervision and assistance with personal care;
 - a nurse on staff at all times.
- Caregiver Retreats offer:
 - relaxation exercises and tips for self-care;
 - entertainment;
 - topics of special interest to caregivers, like managing stress and making difficult care decisions.

FCA Respite Options

- Depending on availability of funds, FCA may be able to provide a stipend that can be used to:
 - hire in-home help through a private provider;
 - use a home care agency that FCA contracts with;
 - enroll in an Adult Day Care Program;
 - temporarily place your loved one in a facility.
