P.1. County Update, Supervisor John Gioia

Ronnie providing an update on the San Pablo dam road rehabilitation. Ronnie explained that the road slope southeast of La Honda will be covered by 80% federal funding and 20% local funding, with projected completion in summer 2026. Ronnie also mentioned current vacancies on various advisory boards and ways to get involved in community service.

Additional discussion including the noise ordinance on the agenda to ensure it is not forgotten, the possibility of federal funding for road improvements, with Ronnie expressing confidence in securing some funding, and inquires about the impact of budget cuts on the county, with Ronnie stating no significant impact has been noted yet.

P.2. Contra Costa County Fire Protection District Update, Chief Dominic Ciotola

Chief Ciolota outlined recent fire district upgrades, including more staff, six new fire engines, two ladder trucks, and a new fire and wildland fire center with helicopters and canine support. He also introduced a nurse navigator program to reduce 911 calls and ER visits. He urged residents to maintain defensible space, keep emergency supplies, and use the Genesis app for real-time updates. A county pre-planning meeting for wildfire season was announced for April. Thomas Lang raised concerns about miscommunication during a previous wildfire, suggesting direct contact between the neighborhood and the fire department. Chief Ciolota agreed to address the issue.

5. Discussion Items: DI. Development plan applications, variance reports, building modification requests, appeals etc., received in the previous month from the Contra Costa County Conservation and Development Department and Notices of Public Hearings.

DI.1 - The applicant requests a Land Use Permit to amend CDLP91-02036 to legalize an existing 960-square-foot modular building at an existing childcare facility, an existing 4-foot-tall retaining wall, and landscaping improvements. The project includes a Tree Permit to allow dripline encroachment of at least one code-protected tree on a further subdividable lot. The application does not include an MWELO review. (See Code Enforcement case CECF24-01048 for more information on prior unauthorized construction.)

01:17:09

A second land use permit was introduced for a modular building and landscaping improvements near the post office. The discussion included concerns about existing unpermitted construction, such as a childcare facility and a retaining wall. The council emphasized the need for compliance with county regulations and suggested landscaping the retaining wall to enhance the property's appearance. Committee members provided various suggestions, including landscape improvements, the importance

of clear addresses, and a new approach to crafting agendas. A county-wide meeting register was also discussed.

UPDATE DI.2 - The applicant is moving towards a development that has less parking and is higher in height for the proposed reconfiguration of 3 lots into 2 lots (Lot A & B). The scope includes doing an addition to the existing car wash and an increase of vacuum stations. The scope also includes demolishing the adjacent existing building to construct a multi-story apartment building on Lot A. Lot A will also include a new park area.

00:34:44

Scott Galka, the project architect, presented a plan to expand the car wash, add vacuum stations, and build a multi-story apartment complex. The project aimed to balance the car wash, community park, and housing, but concerns were raised about parking and noise. Dr. McLain suggested reducing the number of vacuum stations to create more parking. Mikki Norris emphasized the park's importance and urged the car wash to be a responsible neighbor, addressing noise and chemical issues. Tom Owens recommended reconfiguring the vacuum stations to provide more parking for two-bedroom apartments. The council supported the project in principle but requested further adjustments, including additional parking and better communication with the car wash owners.

Lang opened the floor for public comment, with discussions on weekly sign-waving events, the 'Indivisible' El Sobrante movement, the importance of public explanations of community efforts, Citizens for a Greener El Sobrante, park entrance concerns, and the need to repaint and restripe a dangerous intersection. Jurisdiction issues were raised regarding a section of Dam Road maintained by Richmond, its heavy use by El Sobrante residents, the Swim Club's location, and clarifications about El Cerrito's city status. A suggestion was made to notify the city about dangerous intersections and parking concerns. Community safety discussions highlighted the need for accurate location reporting, Caltrans' ownership of traffic cameras, and their potential use for law enforcement. Updates were shared on a church's 70th anniversary, the Good Table Cafe opening, and a district project grant application through Buffy Wicks' office.

- failure, internal decay, bark inclusion and tree structures. Determine trees state of health and liability to the surrounding persons and/or property. 4.
- Inspect canopies and make recommendation for pruning or removal based on trees 5. condition.
- Determine trees ability to withstand proposed construction and make recommendations of 6. proper preservation measures during construction of proposed retaining wall.

On December 16, 2024 18 specified trees located at 5030 San Pablo Dam in El Sobrante were evaluated to determine their safety and liability to surrounding properties. Despite the conclusions and recommendations made in this report, it must be realized that trees are living organisms and their health constantly changes over time. They are not immune to changes from location conditions or variations in the weather. This tree assessment is based on my opinion, experience, and knowledge.

Methodology

These trees were evaluated with guidelines established by the International Society of Arboriculture's Tree Hazard Evaluation Form and the Tree Condition Assessment Form used for tree appraisals. The health assessments were performed without excavation or internal examination such as coring or drilling.

Qualifications

The Arborist Practitioner is an International Society of Arboriculture (ISA) Certified Arborist, must have a State of California Contractors License for tree service (C61-d49) and provide proof of workman's compensation and liability insurance.

All pruning of trees shall be in accordance with the tree pruning guidelines as established by the International Society of Arboriculture and adhere to the most recent edition of the American National Standards Institute for Tree, Shrub and Other Woody plant Maintenance (ANSI A300).




After reviewing site and proposed plans it is evident that all digging and construction will be performed outside the dripline of trees. However specific preservation measures should be performed to reduce impact of trees. All trees shall have all soil near trunk flare left to original soil grade. The proposed construction involves removal of existing retaining wall and installing new concrete retaining wall. The specified trees 1-18 are between 4 & 15'back from existing retaining wall. Tree driplines are outside of digging location. If proper preservation measures are

Proper preservation measures should be as follows. No excavation shall be performed within dripline of trees. If excavation within the dripline shall be performed, hand tools and care shall be taken to preserve all trunk bark intact once project arborist determines where excavation shall


Tree protection fencing should be installed to protect CRZ (critical root zone) and drip line. Tree protection fencing will be constructed of 4ft. orange fencing with steel posts driven 12 inches below grade every 10ft. (see site map). It would be advised to remove deadwood from tree tops and canopies, elevate and reduce lower limbs to prevent damage during construction. Moreover, trees #12 & 13 with codominant leaders should be removed to one stem. All Ivy should be removed from tree canopies and trunks. Tree #17 is dead and should be removed.

All pruning shall be performed by ISA certified personal only and under the direction of the protect Arborist. If proper preservation measures are followed, these trees have a moderate to high survival rate. Certain construction activities should be limited within the tree protection






