4. Chief of Police Report – March '25

a. Still looking for a third BH Officer. Filling the vacancy with overtime for now. All shifts are being covered currently. Anticipate filling this position late May, early June

b. 300 Calls for service: 4 Reports, 1 Felony, no Misdemeanors, and no Arrests.

c. Felonies included:

1) On 3/18/25, a residential burglary occurred on Blackhawk Dr. The suspect(s) entered the residence through a rear gate that was accessible from the Falls Golf Course. Once in the backyard the suspect(s) smashed a glass door leading directly into the primary bedroom. The bedroom was ransacked and take consisted of jewelry and hand bags. The break in occurred between the hours of 6 p.m. and 9 p.m. The Sheriff's Department Crime Lab responded and processed the home for evidence. The case has been assigned to Investigations Division.

d. There were no misdemeanors in March 2025.

e. There was one arrest. On 3/19/25, a female was arrested at her residence for shoplifting. The theft occurred the prior day at a CVS in Danville

Summary for April 2025

The Blackhawk and Valley Station Deputies either initiated or responded to the following calls for service:

- 302 ~ Total calls for service in Blackhawk
- 5 ~ Total police reports were taken in Blackhawk

Felonies - There were 2 felonies reported in the district.

- On 4/16/25, a resident narrowly escaped becoming a fraud victim. The resident received an email stating there was a suspicious purchase using her Pay Pal account. The resident called a number associated with the email and was told the charge would be reversed if she provided a payment first, "to verify her bank account." The victim suspected the call was a scam and ended all communication. The victim later accessed her accounts and found no charge was ever made through her Pay Pal account. The victim suffered no financial loss.
- On 4/21/25, a domestic dispute occurred involving two adult males. During the dispute the suspect battered and threatened the victim. Both parties were contacted on scene and following an investigation the suspect was placed under arrest. The suspect was transported to the Martinez Detention Facility where he was booked for criminal threats.

Misdemeanors - There were no misdemeanors reported in the district.

Arrests – There was one arrest for the month, detailed above in the felony section.

Deputy Nicholas Guido-Serrano will be joining Blackhawk Police Services at our next shift change, occurring in early July. His arrival will bring Blackhawk Police Services to full staff with 3 deputies dedicated to the district, along with myself. I will put out an issue of the Blackhawk Beat soon which will provide a bio for Deputy Guido-Serrano, introducing him to the community.
