3. Public Comment

- **Community Use of Vacant Lot** – Mr. Turner (Local Business Owner) - Mr. Turner requested temporary use of the vacant lot at Investment Street and Parker for community events such as outdoor movie nights. He offered to maintain the site and was advised to submit a permit request to the Department of Conservation and Development, with a response expected by October. The panel thanked him for his initiative, and the request was recorded for follow-up.

6. Agency Reports:

a. Contra Costa County Sheriff Department – Lt. Brian Fitzgerald

- **Calls for Service:** 598 total in Rodeo area over the past month.
- **Reports Taken:** 58
- **Notable incidents:**
 - 2 Batteries (1 domestic-related)
 - 1 Brandishing a Weapon
 - Remaining incidents primarily trespassing-related.
- **Community Inquiry:** Concern raised about woman frequently in distress near Vista.
 - Often refuses services; officers cannot force her to leave or accept help.
 - Continued wellness checks and offers of medical assistance.

b. Contra Costa County Fire Protection District (Con Fire)

- **Calls for Service in August**
 - 87 total calls in Rodeo; 71% were medical-related (62 calls).
 - Slightly down from June/July; considered a normal month.
 - Fire activity typically peaks in June due to dry grass and wind
- **Firewise Program Overview:**
 - Presented by Michelle Reinhartt (Fire Safe Council)
 - Aims to reduce wildfire risk through education and neighborhood collaboration.
 - Encourages forming Firewise Communities (minimum 8 homes).
- **Resident Benefits:**
 - May qualify for insurance discounts and reduce risk of cancellations.
 - Access to free home assessments to identify fire safety improvements.
- **Key Topics Covered:**
 - Defensible space, especially **Zone 0** (0–5 feet from the home).
 - Home hardening techniques (non-combustible landscaping, etc.).
 - Emergency preparedness using:
 - Community Warning System (CWS)
 - Genesis alert app
 - Local evacuation and wildfire readiness guides.
- **Community Discussion Highlights:**
 - No current seismic-related fire risks, but residents encouraged to:
 - Install automatic gas shut-off valves.
 - Prepare homes for infrastructure disruptions.

c. West Contra Costa Unified School District (WCCUSD) – Deborah Brandon

- Introduction of new Superintendent, Dr. Letitia Bia, who has been engaging with schools prior to officially starting.
- Acknowledgment of district's successful superintendent search process.
- Reminder: Transitional Kindergarten (TK) enrollment is open for children who turn 4 by September 1.
- Extended Learning Opportunity program (formerly after-school program) is free to students.
- Student attendance trends will be reported next month; early indications show improved post-break return rates.
- Superintendent Bia praised as a positive addition to the district

d. Office of Supervisor Shanelle Scales-Presto (District 5)

- Community Benefit Advisory Boards for Phillips 66 and Marathon were approved at the September 9 BOS Meeting.
- District 5 Community Impact Fund Survey closes September 30.
- Grant Applications are open until October 31 at 5 PM.
- Rodeo residents can apply to fill the vacant MAC seat via the RMAC website.

e. Contra Costa Office of Education- Lynn Mackie, County Superintendent of Schools

- Shared personal connection to Rodeo and background as former local principal.
- **Countywide Context:**
 - Student population: ~170,000 students
 - 46% from families at or near poverty; 14% with IEPs; ~3,000 homeless students; 776 foster youth.
- **Operations:**
 - 18 school districts plus CCCOE as 19th LEA; oversight of small and medium districts.
- **Board Roles:**
 - Appeals, budget & LCAP approval, oversight of county-operated schools (juvenile hall, expelled programs, jail-based adult education).
- **Services:**
 - Juvenile Court Schools, Adult School in county jails, expelled/truant youth programs
 - Deaf/Hard of Hearing and Visually Impaired services
 - Early intervention programs (birth–3)
 - Career Technical Education (ROP) – A-G approved, over 120 John Swett students
