Minutes of Meeting on March 11, 2025

<u>Guests in Attendance:</u> Deputy Jonathan Ortega, Cameron Collins (Field Representative for the Supervisor's Office), Corey Berla (Resident and Board Member of Round Hill North), Debra Pollay and Chris Gschwend (Round Hill Residents), Peter Melczer (Round Hill District Neighbor)

The P-5 Advisory Committee was held at Round Hill Country Club. Jason Hill called the meeting to order at 7:05 PM. Minutes of the February 11, 2025 meeting were approved unanimously.

<u>Public Comment:</u> Debra Pollay was interested in learning more about the proposed combining of the other Police Districts in Alamo with the P-5 Police District. Chris Gschwend expressed his concern about the speeds of vehicles on Royal Oaks Drive and discussed this issue with Deputy Ortega.

<u>Financial Report:</u> Mark Young reported that his estimate of the Reserve account at the end of FY24-25 will be approximately \$820,000.00. He also reported that his projections for this years budget is inline with expenditures at this point.

P-5 Activity Report: Deputy Ortega discussed the police report which contained a report of mail theft in the area of Lurmann Court, a call to aid an elderly Resident which resulted in the delivery of life saving measures and subsequent transport to the hospital and an episode of stolen packages from the front porch of multiple residences which is an ongoing investigation. His recommendation is

to lock homes, leave lights on, lock cars and secure possessions by closing and locking garage doors. He also recommended removing in a timely manner delivered packages from outside areas to discourage opportunistic theft.

The HOA purchased speed trailer has been moved to Royal Oaks Drive in between Southview Drive and Roundhill Drive along the slope due to complaints of excessive vehicle speeds in the area. If the Committee believes there are any other areas of concern please let him know. As he moves the trailer around to different areas in Round Hill over the coming months he will be able to generate a much more complete picture of where and to what extent speeds exceeding the speed limit are occurring.

There were 16 recorded vehicle stops and warnings were issued for stop sign violations and speeds over the 25 mph limit during February. There were 28 hours of overtime and no out of area assistance noted for February.

Old Business: Discussion continued about the issue of forming a single Alamo Police District. Considering general agreement that the P-5 Committee was in favor of proceeding with the steps to make this a reality Jason Hill made a motion to move forward with the annexation into P-5 all of Alamo (CSA R7 boundary) into a district designated as CSA P5. This motion was seconded by Mark Young and carried unanimously.

New Business: none
