

AMENDMENT NO. 1 TO THE PARTICIPATING ADDENDUM
for
Sewer Vacuum, Hydro-Excavation, and Municipal Pumping Equipment and
Related Accessories and Supplies

Contractor: Vactor Manufacturing, LLC

This Amendment No. 1 ("Amendment") to the Participating Addendum, dated June 24, 2025 ("Agreement"), is made and entered into as of November 18, 2025 ("Amendment Effective Date"), by and between Contra Costa County, a political subdivision of the State of California ("County"), and Vactor Manufacturing, LLC, an Illinois limited liability company ("Contractor"), whose principal place of business is 1621 South Illinois St., Streator, IL 61364. The County and Contractor are sometimes referred to herein together as the "Parties," and each as a "Party."

Recitals

Whereas, the Contractor sells sewer vacuum, hydro-excavation, and municipal pumping equipment and related accessories and supplies under a cooperative purchasing agreement, identified as Contract No. 101221-VTR ("Master Contract"), awarded by Sourcewell, a State of Minnesota public agency, following a competitive solicitation.

Whereas, the County and the Contractor entered into the Agreement to incorporate the terms of the Master Contract, allowing the County to make purchases from the Contractor pursuant to the Master Contract, subject to the terms of the Agreement.

Whereas, the Agreement and the Master Contract were both set to expire on November 29, 2025, but the Agreement provides for a one-year extension, provided that the Master Contract is extended by the same amount of time.

Whereas, Sourcewell and the Contractor executed a Contract Extension, a copy of which is attached hereto, to extend the term of the Master Contract through November 29, 2026, and, therefore, the Parties desire to extend the term of the Agreement by the same amount of time.

Amendment

Now, therefore, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the County and the Contractor agree, as follows:

1. Term. As of the Amendment Effective Date, Section 1 ("Term") of the Agreement is amended to read, as follows:

"1. Term. The term of this Agreement begins on the Effective Date, and it expires on November 29, 2026, unless sooner terminated as provided herein. If the Master Contract is terminated prior to the expiration of the term of this Agreement, the Contractor shall continue to perform under this Agreement until the term of this Agreement expires, or until this Agreement is terminated, whichever occurs first. "

2. Remainder Unchanged. Except to the extent the Agreement is modified by this Amendment, the Agreement remains unchanged and in full force and effect.
