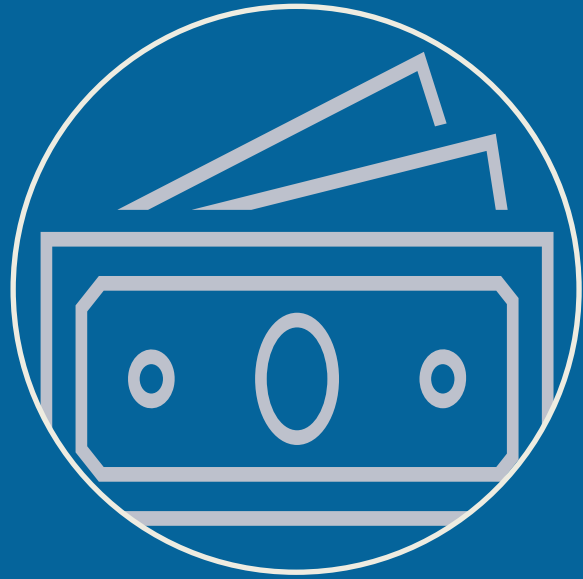

**2,118 people experienced homelessness** in Contra Costa on a given night in 2025



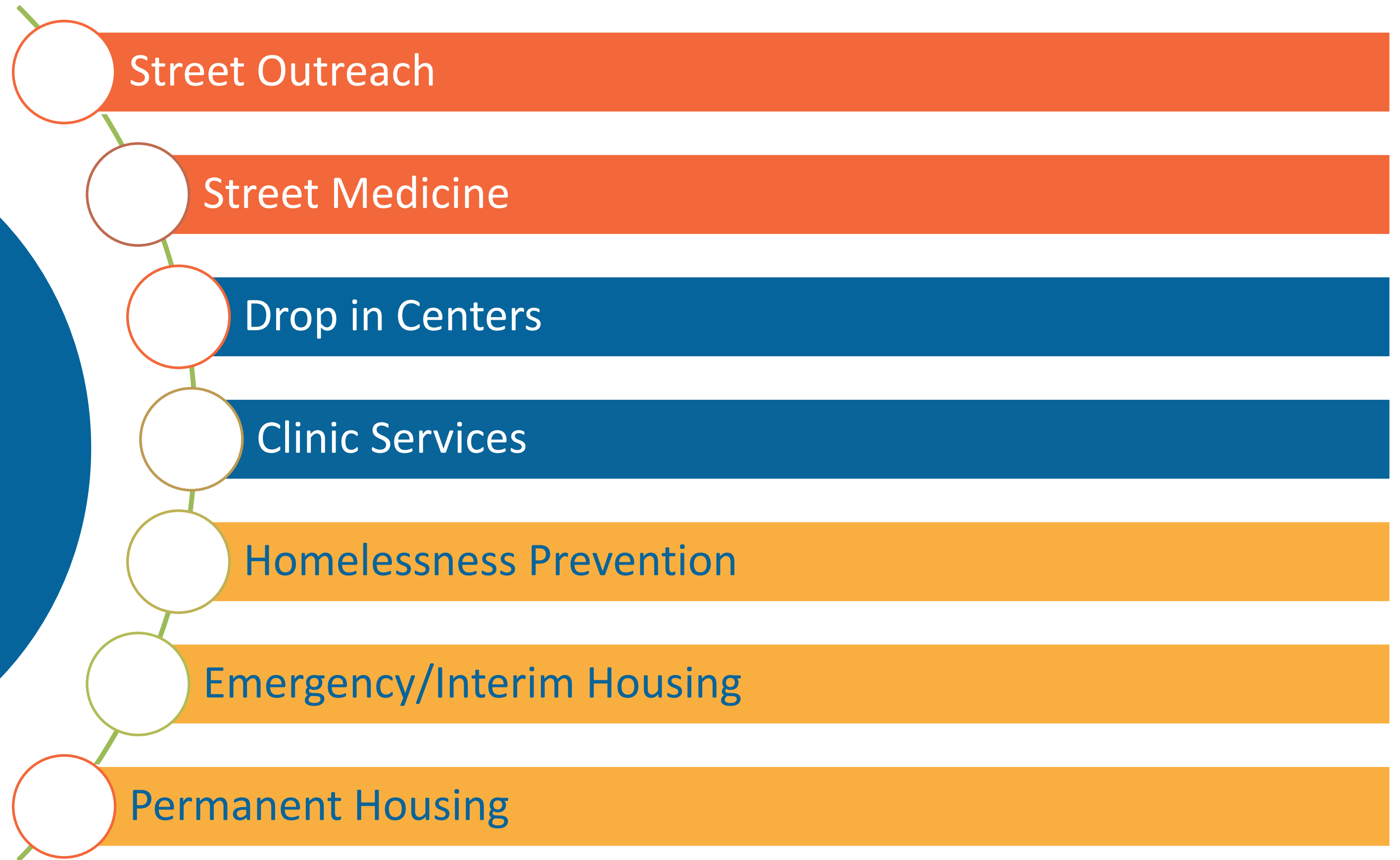

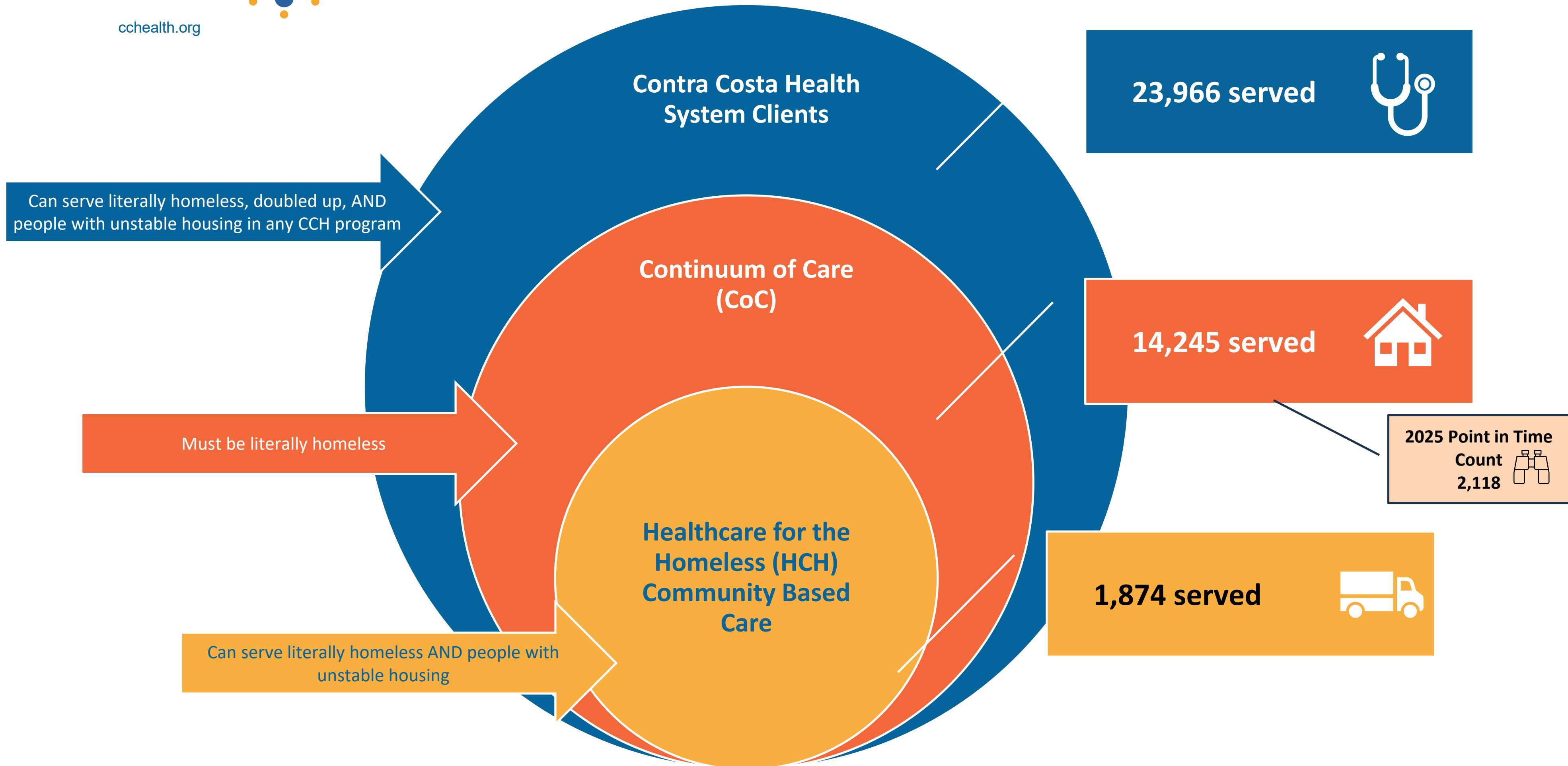

housing (n=1,791)

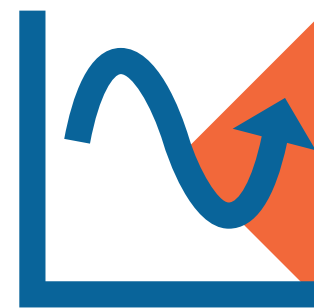

Local investments, like Measure X Housing Fund, are crucial to mitigating federal and state budget threats

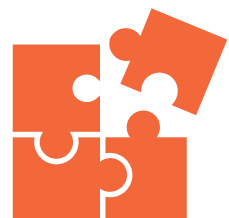
# Impact of Catastrophic Cuts to Federal Funding



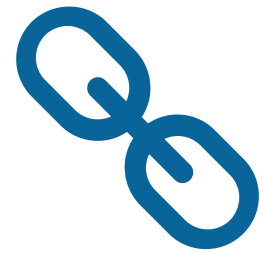
- **Contra Costa residents at risk of losing their homes**
