

Board of Supervisors recently approved awarding the \$10M of Year One funds to affordable housing developers (\$6.5M on May 9) and service providers (\$3.5M on June 13, 2023).

Status: Ongoing

Funds Committed and Leveraged

- All the \$10M in Year One funds have been committed
- The \$12.6M in Year Two funds will be committed by June 30, 2024
- Every dollar of Year One MX Housing Funds has leveraged \$27.50 from other sources.
- Significantly more funding was requested than was available.

Accomplishments

- The Year One RFP processes for housing capital projects and for housingrelated/homelessness response services. were completed in May and June 2023.
- The Board approved \$6.5M for four affordable housing projects to construct 312 new rental units affordable to extremely low, very low, and low-income households.
- The Board approved \$3.5M to 13 service providers to provide various homelessness crisis response and prevention services, including tenant legal services.
- RFP process for Year Two MX Housing Funds (capital projects) began in October 2023.

Housing Capital Projects

Capital projects awarded Year One MX Housing Funds are in the process of finalizing remaining financing. Staff will return to the Board to approve legal/loan documents for each respective capital project as they approach construction close.

RFP process for Year Two MX Housing Funds started on October 12, 2023, and an RFP Technical Assistance Meeting was held on November 2, 2023.

- Measure X funding used as match to secure \$695,000 Clean California grant from CalTrans to expand the program
- 122 Derelict RVs and boats removed from County (CYs 2021, 2022, & 2023
 YTD)
- Number of capital improvements: 52 new deterrent signs have been installed countywide
- Enforcement Highlights: 279 citizen clean-up reports, 115 investigations, 36 cases forwarded to DA, 3 citations issued, 8 dump sites self-cleaned prior to enforcement (FYs 21/22 & 22/23)
- Governor signed two County sponsored bills: AB 592 increases county authority to regulate waste hauling in unincorporated roadways,
 SB 409 - increases penalties for commercial dumping
- 2,490 illegally dumped waste tires cleaned up (FYs 21/22 & 22/23)


Making It Easier to Report Illegal Dumping

In addition to traditional phone and email methods, Public Works (PW) has established two online request options to report illegal dumping. The first option is the Mobile Citizen App. The second option is the PW Customer Portal found on the PW website.


By October 2023, PW received 516 illegal dumping complaints through the Mobile Citizen App, 95 illegal dumping complaints through the Customer Portal, and 293 illegal dumping complaints from traditional methods.








Requests for Illegal Dumping Clean Up Received by Public Works and North Richmond Hot Spot Crew in 2022




MEASUREX CLIMATE EQUITY AND RESILIENCE: PROGRESSTO DATE

October 2023

- Sea Level Rise Develop plans and collaboratives to take action on the many existing studies of sea level rise in Contra Costa County.
- Climate Resilience Identify challenges presented by extreme heat, wildfires, drought, and related climate impacts, and begin developing plans to help the County be more climate resilient.
- Community-facing clean energy projects and programs Facilitate programs that allow low- and moderate-income property owners and renters to take advantage of solar energy, electric vehicles, and allelectric buildings.
- Financing programs Facilitate opportunities for low- and moderate-income property owners and renters to finance clean energy projects and programs.
- **Economic Transition** -- Support work by the Board of Supervisors on the climate-related aspects of planning for a transition away from an economy based on fossil fuels.
- Strategies to sequester carbon Take action on the findings of an ongoing, grant-funded study of opportunities to sequester carbon in the many land uses in the County.


Climate Equity and Resilience Priorities



Sea Level Rise

- Staff are supporting the newly established Board of Supervisors ad hoc committee, the Contra Costa Resilient Shoreline Ad Hoc Committee on Sea Level Rise. The Committee on Sea Level Rise's work will lead us on developing Contra Costa County sea level rise adaptation and resilience project recommendations for the full Board's consideration.
- Staff submitted three applications for grants to support the development of the Contra Costa County Sea Level Rise Resilience and Adaptation Plan (SLR Plan). These grants would fund robust community engagement and visioning activities to inform focused adaptation strategies and implementation actions for the communities along Contra Costa County's shoreline.
- Staff are building the **Contra Costa Resilient Shoreline Coalition**. We met with all shoreline cities and several other organizations (*e.g.* special districts, CBOs, NGOs) and secured letters of support to partner on these grant applications. 
Financing Programs



- Sustainability staff published a new webpage titled "Sustainability Resources." The webpage houses a list of local, state, and federal incentive programs available to Contra Costa County residents and businesses. Incentive topics include energy efficiency and all-electric buildings, solar panels, battery storage systems, water efficiency, and transportation.
- DCD partnered with the County Library on a lunch and learn webinar to introduce the ongoing state and federal clean energy funding opportunities listed on the "Sustainability Resources" webpage.

Climate Resilience

- Staff continued research on climate resilience and resilience hub case studies and grant opportunities.
- Staff participated in the Urban Sustainability Directors Network Resilience Hub Community of Practice.
- DCD structured the Q3 meeting of the countywide Sustainability Exchange to focus on climate resilience.




Climate Equity

- On August 1, staff submitted an application to the California Strategic Growth Council for a \$300,000 planning grant for **Bay Point** from the Transformative Climate Communities program.
- Five local, community-based organizations are coapplicants: Rising Juntos, the Center for Human Development, Healthy and Active Before 5, La Clinica, and Sustainable Conservation.
- Staff from the Departments of Conservation and Development, Public Works, and Health collaborated on this application.



Just Transition

- The Just Transition Economic Revitalization Plan (JTERP) is in the initiation phase.
 - The County has executed an agreement with U.S. Housing and Urban Development Department for \$750,000 to conduct the public engagement, analytic and planning work associated with the JTERP.
- Staff are supporting the launch of the Green Empowerment Zone, which will be funded by a \$5 million allocation from the State of California.



Community-facing clean energy projects and programs

- Staff presented a first draft of a roadmap to convert existing buildings in Contra Costa County to clean energy.
- Staff expect to have a final report for the Board to accept by the end of 2023.
